B. CONDITIONS OF TITLE

The Conditions of Title mentioned in paragraph A13 are as follows:

B1 In favour of the Woodland Hills Home Owners' Association

This erf is subject to a servitude of 2,25 metre wide along any of the boundaries except the street boundary for the installation of municipal service mains over or under the erf.

B2 In favour of the Woodland Hills Home Owners' Association

The Woodland Hills Home Owners' Association shall at all times have free access thereto for the purposes of construction, maintenance and repair of the services: Provided that the Town Owner shall have the right to store all material required for the above-mentioned purposes, temporarily on the erf until such time as the installation of the services has been compiled.

B3 This erf may not be subdivided

B. EIENDOMSVOORWAARDES

Die Eiendomsvoorwaardes wat in paragraaf A13 vermeld word, is soos volg:

B1 Ten gunste van die Woodland Hills Huseienaarsvereniging
