Attention is directed to the provisions of Section 65 and 67 of the Free State Gambling & Liquor Act, No 6 of 2010 as amended, which makes provision for the lodging of written representations in respect of the application.

Written representations should be lodged with the Chief Executive Officer, Free State Gambling, Liquor and Tourism Authority, 111 Zastron Street, Bloemfontein, 9301, South Africa, within one month from **30 November 2018**.

Such representations shall contain at least the following information:

- (a) the name of the applicant to which representations relate;
- (b) the ground or grounds on which representations are made;
- (c) the name, address, telephone and fax number of the person submitting the representations
- (d) whether the person submitting the representations requests the Authority to determine that such person's identity may not be divulged and the grounds for such request; and
- (e) whether or not they wish to make oral representations at the hearing of the application.

Any representations not containing the information required above shall be of no force or effect and shall be deemed not to have been lodged with the Authority.
