Notice is hereby given in terms of Section 49(1) (a) (i) read together with Section 78(2) of the Local Government: Municipal Property Rates Act, 2004 (Act No. 6 of 2004), hereinafter referred to as the "Act", that the first supplementary valuation roll for Sectional titles for the financial years 2018/2019 is open for public inspection at the local municipal offices in Boshof, Dealesville and Hertzogville.

Inspections can be done from 22 October 2018 – 26 November 2018 during office hours: 07:30 to 16:00 from Mondays to Fridays.

An invitation is hereby made in terms of Section 49(1)(a)(ii) read together with Section 78(2) of the Act that any owner of property or other person who so desires should lodge an objection with the Municipal Manager in respect of any matter reflected in, or omitted from, the first supplementary valuation roll for Sectional titles within the above-mentioned period. Closing date is 26 November 2018 at 16:00.

Attention is specifically drawn to the fact that in terms of section 50(2) of the Act an objection must be in relation to a specific individual property and not against the valuation roll as such.
