NOTICE OF APPLICATION FOR LIQUOR REGISTRATION

Notice is hereby given that each of the applicants mentioned in the Schedule hereunder intends to lodge an application for liquor registration on the first Friday of this month.

Any person may, within 21 days from date of publication of this notice, lodge in terms of section 33 of the Free State Gambling and Liquor Act, 2010, an objection in writing to the Free State Gambling and Liquor Authority (*addresses set out hereunder*).
