No. 33 (Premier's), 1994

LOCAL GOVERNMENT TRANSITION ACT, 1993
(ACT No. 209 OF 1993)

CITY COUNCIL OF GREATER BENONI

Under section 10 of the Local Government Transition Act, 1993 (Act No. 209 of 1993), I hereby, with the concurrence of the Provincial Committee, make the enactments in the Schedule.

SCHEDULE

Establishment of Transitional Local Council

1. A transitional local council, hereunder called the City Council of Greater Benoni, is hereby established as contemplated in section 7 (1) (b) (i) of the Local

BYLAE

Instelling van Plaaslike Oorgangsraad

1. 'n Plaaslike oorgangsraad, hieronder die Stadsraad van Groter Benoni genoem, word hierby, soos beoog in artikel 7 (1) (b) (i) van die Oorgangswet

Government Transition Act, 1993 (Act No. 209 of 1993), with effect from the date upon which this Proclamation shall come into operation (hereunder called the effective date), comprising the City Councils of Benoni and Daveyton, and the Town Council of Wattville, which City Council of Greater Benoni shall be deemed to be a local authority in terms of the Local Government Ordinance, 1939 (Ordinance No. 17 of 1939).

Dissolution of local government bodies

2. The City Councils of Benoni and Daveyton and the Town Council of Wattville are hereby dissolved on the effective date.

Area of City Council of Greater Benoni

3. The area of the City Council of Greater Benoni comprises the existing area of jurisdiction of the dissolved City Council of Benoni as defined in Government Notice No. 57 of 2 August 1907, as amended or extended, the area of the dissolved City Council of Daveyton as defined in Administrator's Notice No. 2047 of 16 September 1983, as amended or extended and the area of the dissolved Town Council of Wattville, as defined in Administrator's Notice No. 2050 of 16 September 1983, as amended or extended.

Councillors

4. (1) The City Council of Greater Benoni comprises 50 Councillors.

(2) The terms of office of the Councillors of the dissolved local government bodies mentioned in section 2 shall be terminated on the effective date.

(3) The persons mentioned in Annexure A, and duly nominated in terms of paragraph 5 of Schedule 1 to the Local Government Transition Act, 1993, are hereby appointed as Councillors of the City Council of Greater Benoni.

(4) Any casual vacancy arising on the City Council of Greater Benoni as from the effective date shall be reported to the Member for Housing and Local Government of the Executive Council within thirty days, which vacancy shall, notwithstanding the provisions of sections 20 and 36 of the Municipal Elections Ordinance, 1970 (Ordinance No. 16 of 1970), be filled by the competent authority from the list of additional candidates in order of preference as contemplated in paragraph 5 of Schedule 1 to the Local Government Transition Act, 1993, as contained in Annexure B.

Mayor and Deputy Mayor

5. The City Council of Greater Benoni shall, within seven days as from the effective date, at a special meeting of the City Council of Greater Benoni, in the manner prescribed for the election of a Mayor and Deputy Mayor in sections 16 and 17 respectively, of the Local Government Ordinance, 1939, elect a Mayor and a Deputy Mayor from the Councillors mentioned in section 4 (3).

Ontbinding van plaaslike owerheidsliggame

2. Die Stadsrade van Benoni en Daveyton en die Dorpsraad van Wattville word hierby op die effektiewe datum ontbind.

Gebied van Stadsraad van Groter Benoni

3. Die gebied van die Stadsraad van Groter Benoni bestaan uit die bestaande regsgebied van die ontbinde Stadsraad van Benoni soos omskryf in Goewermentskennisgewing No. 57 van 2 Augustus 1907, soos gewysig of uitgebrei, die gebied van die ontbinde Stadsraad van Daveyton, soos omskryf in Administrateurskennisgewing No. 2047 van 16 September 1983, soos gewysig of uitgebrei, en die gebied van die ontbinde Dorpsraad van Wattville, soos omskryf in Administrateurskennisgewing No. 2050 van 16 September 1983, soos gewysig of uitgebrei.

Raadslede

4. (1) Die Stadsraad van Groter Benoni bestaan uit 50 Raadslede.

(2) Die ampstermyne van die Raadslede van die ontbinde plaaslike owerheidsliggame in artikel 2 vermeld, word op die effektiewe datum beëindig.

(3) Die persone in Aanhangel A vermeld, wat behoorlik kragtens paragraaf 5 van Bylae 1 by die Oorgangswet op Plaaslike Regering, 1993, benoem is, word hierby as Raadslede van die Stadsraad van Groter Benoni aangestel.

(4) Enige toevallige vakature wat vanaf die effektiewe datum op die Stadsraad van Groter Benoni ontstaan, moet binne dertig dae aan die Lid vir Behuising en Plaaslike Regering van die Uitvoerende Raad gerapporteer word, welke vakature, ondanks die bepalinge van artikels 20 en 36 van die Ordonnansie op Munisipale Verkiesings, 1970 (Ordonnansie No. 16 van 1970), deur die bevoegde gesag gevul word uit die lys van bykomende kandidate in orde van voorkeur soos beoog in paragraaf 5 van Bylae 1 by die Oorgangswet op Plaaslike Regering, 1993, in Aanhangel B vervat.

Burgemeester en Onderburgemeester

5. Die Stadsraad van Groter Benoni verkies, binne sewe dae vanaf die effektiewe datum op 'n spesiale vergadering van die Stadsraad van Groter Benoni, 'n Burgemeester en 'n Onderburgemeester uit die Raadslede in artikel 4 (3) vermeld op die wyse voorgeskryf vir die verkiesing van 'n Burgemeester en Onderburgemeester by artikels 16 en 17 respektiewelik van die Ordonnansie op Plaaslike Bestuur, 1939.

Executive and other Committees

6. (1) The City Council of Greater Benoni shall, within seven days as from the effective date, notwithstanding the provisions of the Local Government (Administration and Elections) Ordinance, 1960 (Ordinance No. 40 of 1960), in terms of the provisions of section 16 (6) of the Local Government Transitional Act, 1993, elect from its members an Executive Committee.

(2) The City Council of Greater Benoni shall elect one member of the Executive Committee as Chairperson and one member as Vice-Chairperson of the Executive Committee.

(3) The provisions of sections 1 and 55 to 61 of the Local Government (Administration and Elections) Ordinance, 1960, shall, for the purposes of this Proclamation, be applicable *mutatis mutandis* to the Executive Committee contemplated in subsection (1).

(4) The Council may appoint one or more Committees other than the Executive Committee contemplated in subsection (1), and invest such committee or committees with such powers, functions and duties as the Council may deem fit.

Transfer of assets, liabilities, rights, obligations and successor-in-law

7. (1) All assets, liabilities, rights and obligations of the dissolved local government bodies mentioned in section 2 shall, as from the effective date and subject to the provisions of subsection (3), be transferred to the City Council of Greater Benoni.

(2) The City Council of Greater Benoni shall for the purposes of this Proclamation, as from the effective date and subject to the provisions of subsection (3), be deemed to be the successor-in-law of the dissolved local government bodies concerned.

(3) Any liability, debt or obligation which has been incurred by the dissolved black local government body mentioned in section 2, namely the dissolved City Council of Daveyton, up to and including the day preceeding the effective date, other than a liability, debt or obligation which has been incurred in respect of any infrastructure that generates revenue or infrastructure which is or can be utilised by the City Council of Greater Benoni, shall devolve upon the City Council of Greater Benoni subject to the right of the national government to assume such liabilities, debts or obligations in terms of assurances made by the national government that no transitional council will inherit any external debts of the said black local government body up to the effective date.

By-laws, regulations, resolutions, statutory notices and delegations

8. Subject to the provisions of this Proclamation, all by-laws, regulations, resolutions, statutory notices and delegations of the dissolved City Council of Benoni shall be the by-laws, regulations, resolutions, statutory notices and delegations of the City Council of Greater Benoni: Provided that where such by-laws, regulations,

Uitvoerende en ander Komitees

6. (1) Die Stadsraad van Groter Benoni verkies binne sewe dae vanaf die effektiewe datum, ondanks die bepalings van die Ordonnansie op Plaaslike Bestuur (Administrasie en Verkiesings), 1960 (Ordonnansie No. 40 van 1960), ingevolge artikel 16 (6) van die Oorgangswet op Plaaslike Regering, 1993, uit sy lede 'n Uitvoerende Komitee.

(2) Die Stadsraad van Groter Benoni verkies een lid van die Uitvoerende Komitee as Voorsitter en een lid as Ondervoorsitter van die Uitvoerende Komitee.

(3) Die bepalings van artikels 1 en 55 tot 61 van die Ordonnansie op Plaaslike Bestuur (Administrasie en Verkiesings), 1960, is, by die toepassing van hierdie Proklamasie, *mutatis mutandis* op die Uitvoerende Komitee in subartikel (1) bedoel van toepassing.

(4) Die Raad kan bykomend tot die Uitvoerende Komitee in subartikel (1) bedoel, een of meer komitees aanstel, en sodanige komitee of komitees met sodanige magte, funksies en pligte beklee as wat die Raad goed mag ag.

Oordra van bates, laste, regte, verpligtinge en regsopvolger

7. (1) Alle bates, laste, regte en verpligtinge van die ontbinde plaaslike owerheidsliggame in artikel 2 vermeld word vanaf die effektiewe datum, en behoudens die bepalings van subartikel (3), aan die Stadsraad van Groter Benoni oorgedra.

(2) Die Stadsraad van Groter Benoni word vanaf die effektiewe datum, en behoudens die bepalings van subartikel (3), vir die doeleindes van hierdie Proklamasie geag die regsopvolger van die ontbinde plaaslike owerheidsliggame in artikel 2 vermeld te wees.

(3) Enige las, skuld of verpligting wat deur die ontbinde swart plaaslike owerheidsliggaam vermeld in artikel 2, naamlik die Stadsraad van Daveyton, aangegaan is tot op en insluitend die dag wat die effektiewe datum voorafgegaan, behalwe 'n las, skuld of verpligting wat aangegaan is ten opsigte van enige infrastruktuur wat inkomste genereer of infrastruktuur wat deur die Stadsraad van Groter Benoni aangewend word of kan word, gaan op die Stadsraad van Groter Benoni oor onderhewig aan die reg van die nasionale regering om diesulke laste, skuld of verpligtinge te aanvaar kragtens versekerings gemaak deur die nasionale regering dat geen oorgangsraad enige eksterne skulde van die genoemde swart plaaslike owerheidsliggaam tot op die effektiewe datum sal erf nie.

Verordeninge, regulasies, besluite, wetlike kennisgewings en delegasies

8. Behoudens die bepalings van hierdie Proklamasie word alle verordeninge, regulasies, besluite, wetlike kennisgewings en delegasies van die ontbinde Stadsraad van Benoni die verordeninge, regulasies, besluite, wetlike kennisgewings en delegasies van die Stadsraad van Groter Benoni: Met dien verstande dat

resolutions, statutory notices and delegations are inapplicable in the areas of the dissolved City Council of Daveyton or the dissolved Town Council of Wattville, the relevant by-laws, regulations, resolutions, statutory notices and delegations which were applicable in those areas before the effective date, shall be applicable.

Budget

9. The 1994/95 budget of the local government bodies referred to in section 2 shall, notwithstanding the provisions of section 58 of the Local Government Ordinance, 1939, be deemed to be the 1994/95 budget of the City Council of Greater Benoni until a single consolidated budget is approved.

Representation on Regional Services Council

10. Representation of the dissolved local government bodies referred to in section 2 before the effective date in terms of the Regional Services Councils Act, 1985, (Act No. 109 of 1985) on the East Rand Regional Services Council, shall be terminated on the effective date.

Authorized local authority

11. (1) The City Council of Greater Benoni is, under the provisions of section 2 of the Town-planning and Townships Ordinance, 1986 (Ordinance No. 15 of 1986), as from the effective date, deemed to be an authorized local authority for the purpose of Chapters II, III and IV of the said Ordinance.

(2) The City Council of Greater Benoni is, under the provisions of section 3 of the Division of Land Ordinance, 1986 (Ordinance No. 20 of 1986), as from the effective date, deemed to be an authorized local authority for the purposes of Chapter IV of the said Ordinance.

Local authority contemplated in Sixth Schedule to Local Government Ordinance, 1939

12. The City Council of Greater Benoni is hereby, as from the effective date, deemed to be a local authority as contemplated in Part I of the Sixth Schedule to the Local Government Ordinance, 1939.

Single Local Administration of City Council of Greater Benoni

13. (1) A single Local Administration is hereby established for the City Council of Greater Benoni.

(2) A permanent organisational structure for the Single Administration shall be constituted by the City Council of Greater Benoni as soon as possible after the effective date.

Acting Chief Executive Officer/Acting Town Clerk

14. (1) The Chief Executive Officer/Town Clerk of the dissolved City Council of Benoni shall, for the purposes of this Proclamation, and subject to the provisions of the Remuneration of Town Clerks Act, 1984 (Act No. 115 of 1984), and the Profession of Town

Begroting

9. Die 1994/95-begroting van die plaaslike owerheidsliggame in artikel 2 vermeld word, ondanks die bepalings van artikel 58 van die Ordonnansie op Plaaslike Bestuur, 1939, geag die 1994/95-begroting van die Stadsraad van Groter Benoni te wees, totdat 'n enkele gesamentlike begroting goedgekeur word.

Verteenwoordiging op Streeksdiensteraad

10. Verteenwoordiging wat die ontbinde plaaslike owerheidsliggame in artikel 2 vermeld kragtens die Wet op Streeksdiensterade, 1985 (Wet No. 109 van 1985), voor die effektiewe datum op die Oos-Rand Streeksdiensteraad gehad het, word op die effektiewe datum beëindig.

Gemagtigde plaaslike bestuur

11. (1) Die Stadsraad van Groter Benoni word, kragtens die bepalings van artikel 2 van die Ordonnansie op Dorpsbeplanning en Dorpe, 1986 (Ordonnansie No. 15 van 1986), vanaf die effektiewe datum geag 'n gemagtigde plaaslike bestuur vir doeleindes van Hoofstukke II, III en IV van genoemde Ordonnansie te wees.

(2) Die Stadsraad van Groter Benoni word, kragtens die bepalings van artikel 3 van die Ordonnansie op die Verdeling van Grond, 1986 (Ordonnansie No. 20 van 1986), vanaf die effektiewe datum geag 'n gemagtigde plaaslike bestuur vir doeleindes van Hoofstuk IV van genoemde Ordonnansie te wees.

Plaaslike bestuur in Sesde Bylae by Ordonnansie op Plaaslike Bestuur, 1939, gedoel

12. Die Stadsraad van Groter Benoni word hierby, vanaf die effektiewe datum, geag 'n plaaslike bestuur soos bedoel in Deel I van die Sesde Bylae by die Ordonnansie op Plaaslike bestuur, 1939, te wees.

Enkele plaaslike Administrasie vir Stadsraad van Groter Benoni

13. (1) 'n Enkele Plaaslike Administrasie word hierby vir die Stadsraad van Groter Benoni ingestel.

(2) 'n Permanente organisatoriese struktuur vir die Enkele Administrasie moet deur die Stadsraad van Groter Benoni so spoedig moontlik na die effektiewe datum saamgestel word.

Waarnemende Hoof Uitvoerende Beampte/Waarnemende Stadsklerk

14. (1) Die Hoof Uitvoerende Beampte/Stadsklerk van die ontbinde Stadsraad van Groter Benoni word by die toepassing van hierdie Proklamasie, behoudens die bepalings van die Wet op die Besoldiging van Stadsklerke, 1984 (Wet No. 115 van 1984), en die Wet

Clerks Act, 1988 (Act No. 75 of 1988), be deemed to be the Acting Chief Executive Officer/Acting Town Clerk of the City Council of Greater Benoni as contemplated in section 62 of the Local Government Ordinance, 1939.

(2) The Acting Chief Executive Officer/Acting Town Clerk shall, for the purposes of this Proclamation perform all the functions, powers and duties assigned to a Chief Executive Officer/Town Clerk in terms of the Local Government Ordinance, 1939, the Local Government (Administration and Elections) Ordinance, 1960, the Municipal Elections Ordinance, 1970, or any other law, by-law or resolution of the dissolved local government bodies mentioned in section 2.

Employees and officers of City Council of Greater Benoni

15. (1) All employees and officers in the service of the dissolved Local Government Bodies mentioned in section 2 and the employees and officers employed by the City Council of Greater Benoni prior to the constitution of a permanent organizational structure as contemplated in section 13 (2), shall be deemed to be transferred to the Single Local Administration contemplated in section 13 (1), with retention of their present rights, benefits, remuneration, status and conditions of service.

(2) The City Council of Greater Benoni shall as soon as possible after the effective date constitute a permanent organizational structure as contemplated in section 13 (2) to which all employees and officers mentioned in subsection (1) shall be appointed subject to the provisions of sections 10 (3) (f) (i) and (j) of the Local Government Transition Act, 1993.

Effective date

16. This Proclamation shall come into operation on 7 December 1994.

(2) Die Stadsraad van Groter Benoni stel so spoedig moontlik na die effektiewe datum 'n permanente organisatoriese struktuur soos in artikel 13 (2) bedoel saam, waarin alle werknemers en beamptes in subartikel (1) vermeld aangestel word ooreenkomstig die bepalings van artikel 10 (3) (f) (i) en (j) van die Oorgangswet op Plaaslike Regering, 1993.
