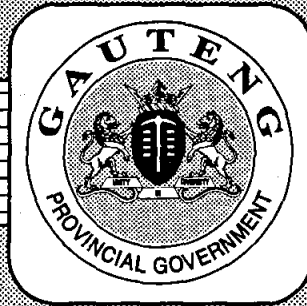

##### INCREASE OF TARIFFS

It is hereby notified in terms of section 80B of the Local Government Ordinance, 1939 (Ordinance 17 of 1939) that the Town Council of Centurion intends by special resolution, to amend the charges in respect of sewerage.

The general purport of these amendments is to increase certain charges in respect of sewerage as from 1 July 1995.
