Act No. 3, 1998

PROVINCIAL ADJUSTMENTS APPROPRIATION ACT

ACT

To appropriate an adjusted amounts of money for the requirements of the Province in respect of the financial year ending 31 March 1998

> (English text signed by the Premier) (Assented to 31 March 1998)

B^E IT ENACTED by the Provincial Legislature of Gauteng, as follows:—

1. Subject to the provisions of the Provincial Exchequer Act, 1994 (Act No. 1 of 1994), there are hereby appropriated out of the Provincial Revenue Fund for the requirements of the Province in respect of the financial year ending 31 March 1998, as a charge to the Provincial Revenue Account, the adjusted amounts of money shown in column 1 of the Schedule.

Short Title

2. This Act shall be called the Provincial Adjustments Appropriation Act, 1998.
