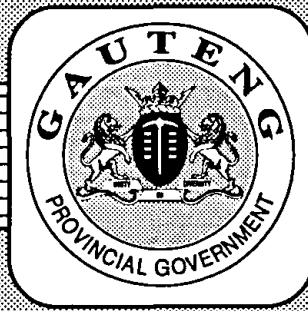

PROCLAMATION

Premier of the Province of Gauteng

COMMISSION OF ENQUIRY INTO ACTS OF CORRUPTION AND OTHER IRREGULARITIES WITH REGARD TO THE ALLOCATION AND/OR SALE OF STATE-FUNDED RESIDENTIAL PROPERTIES IN THE URBAN AREAS OF GAUTENG
