No. 26 (Premier's), 1998

REMUNERATION AND ALLOWANCES OF MEMBERS OF THE PROVINCIAL LEGISLATURE.

In terms of section 2 (1) of Payment of Members of the Provincial Legislature Act, 1995 (Act No. 1 of 1995) (hereinafter referred to as the Act), I hereby determine that the annual remuneration and allowances for the various grades of members of the Provincial Legislature specified in column 1 of the Schedule shall be as specified in Column 2 of the Schedule with effect from 1 September 1998.

In terms of section 2 (3) (a) of the Act, I determine the amount of R40 000 per annum as that portion of the remuneration of a member of the Legislature to which paragraph (d) of section 8 (1) of the Income Tax Act, 1962 (Act No. 58 of 1962), must apply.




