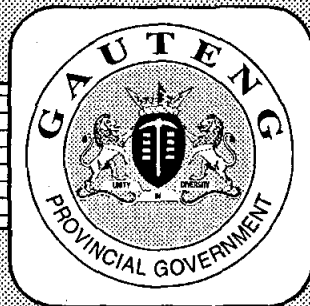

**INVITATION BY THE MEMBER OF THE EXECUTIVE COUNCIL: FINANCE
AND ECONOMIC AFFAIRS, GAUTENG PROVINCE, FOR NOMINATIONS TO
THE CONSUMER AFFAIRS COURT**

1. A call for nominations for a member, an alternate chairperson and one alternate member for the Consumer Affairs Court is hereby made in terms of section 14 of the Gauteng Consumer Affairs (Unfair Business Practices) Act, 1996 by the Member of the Executive Council responsible for Finance and Economic Affairs. It is the intention that the appointments will be finalised at public hearings on 27 October 1998.

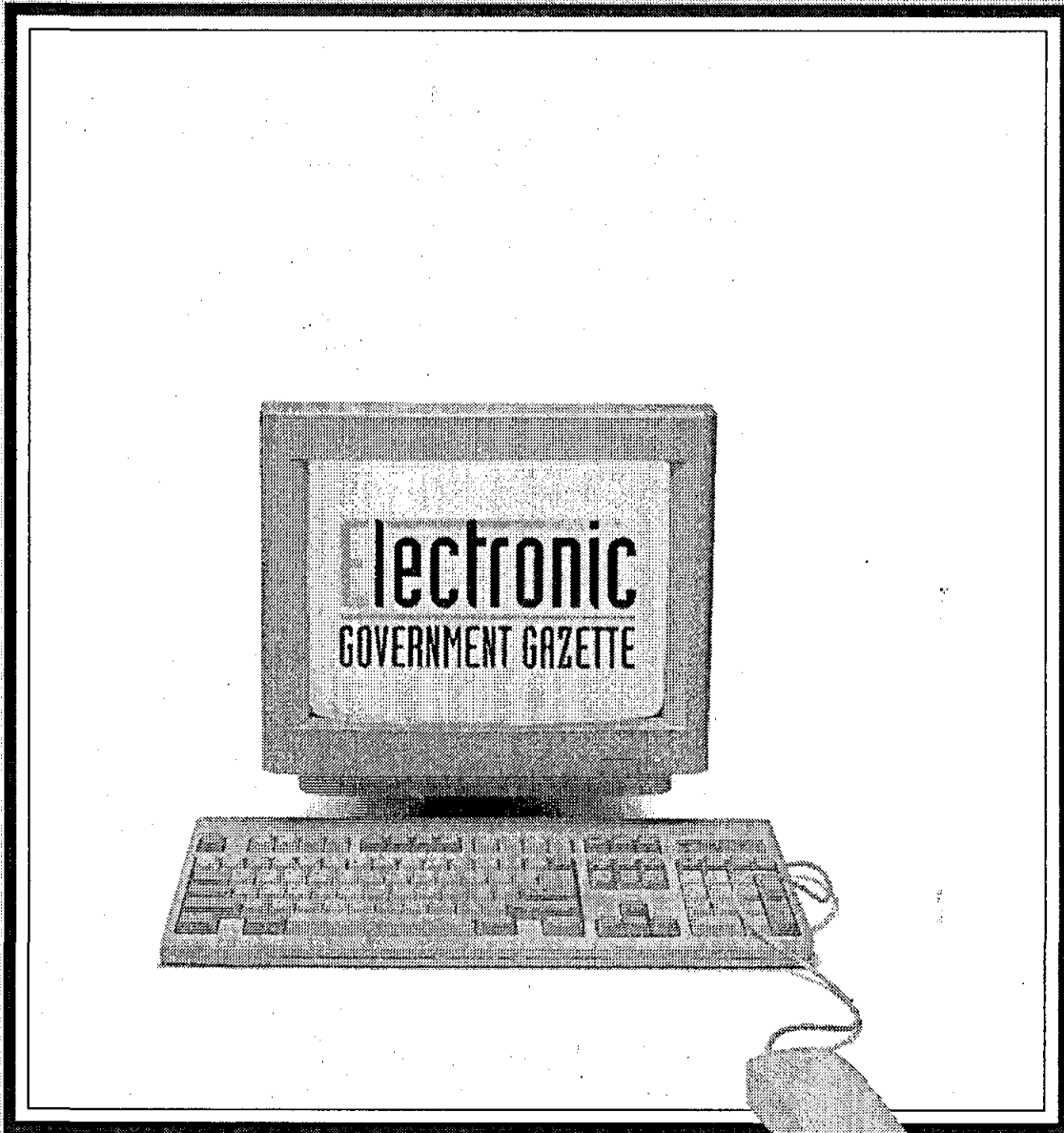
2. (i) All interested parties are invited to submit written nominations for these positions in the Consumer Affairs Court as soon as possible. Such nominations should be forwarded to:

- (ii) The member, alternate chairperson and alternate member of the Consumer Affairs Court shall be appointed by the responsible Member in concurrence with the Standing Committee on Finance and Economic Affairs in the Gauteng Legislature.

The alternate chairperson of the Consumer Affairs Court shall be a retired judge of the Supreme Court; or an attorney, advocate, retired magistrate or lecturer in law at a university, with not less than 10 years cumulative experience in one or more such capacities; and the member and alternate member of the Consumer Affairs Court shall have special knowledge or experience of consumer advocacy, economics, industry or commerce. Interviews of nominees shall be open to the public.

- (iii) No person shall be appointed or remain a member of a court if he or she is not a fit and proper person or -
- is not a citizen of the Republic resident in the Province;
 - is a public servant;
 - at the relevant time is, or during the preceding 12 months was, an office-bearer or employee of any party, movement, organisation or body of a party political nature;
 - is an unrehabilitated insolvent;
 - has at any time been convicted, whether in the Republic or elsewhere, of theft, fraud, forgery or uttering a forged document, perjury, an offence under this Act or the Corruption Act, 1992 (Act No. 94 of 1992), or any offence involving dishonesty; or
 - has at any time been removed from an office of trust on account of misconduct.
- (iv) Nominations should be made by not later than 21 October 1998.
- (v) The name, telephone number or fax number and address of a person who may be contacted in regard to the nomination should also be stated clearly.
