No. 1 of 1999: Gauteng Unauthorised Expenditure Act, 1999.

ACT

To provide for authorisation of certain unauthorised expenditure from the provincial revenue account; and to provide for matters incidental thereto

(English text signed by the Premier) (Assented on 2 March 1999)

E IT ENACTED by the Provincial Legislature of Gauteng, as follows:—

Authorisation of certain unauthorised expenditure from provincial revenue account

- 1. (1) Expenditure to the amount of R405 731 335 incurred by Gauteng Provincial Asministration during the periods April 1995 to March 1996, in respect of services rendered by the Gauteng Provincial Administration without legal authorisation, is hereby authorised.
- (2) The Provincial Revenue Account is charged with the expenditure contemplated in subsection (1).
 - (3) The expenditure referred to in subsection (1) is set out in the schedule hereto.

Short title

2. This Act is called Gauteng Unauthorised Expenditure Act, 1999.

No. 2 of 1999: Provincial Adjustments Appropriation Act, 1999.

ACT

To appropriate adjusted amounts of money for the requirements of the Province in respect of the financial year ending 31 March 1999

(English text signed by the Premier) (Assented to on 2 March 1999)

BE IT ENACTED by the Provincial Legislature of Gauteng, as follows:—

1. Subject to the provisions of the Provincial Exchequer Act, 1994 (Act No. 1 of 1994), there are hereby appropriated out of the Provincial Revenue Fund for the requirements of the Province in respect of the financial year ending 31 March 1999, as a charge to the Provincial Revenue Account, the adjusted amounts of money shown in column 1 of the Schedule.

Short title

2. This Act shall be called the Provincial Adjustments Appropriation Act, 1999.
