

GAUTENG INTERIM MINIBUS TAXI-TYPE SERVICES ACT, 1997 (ACT No. 11 OF 1997)

APPLICATION OF SPECIAL MEASURES IN THE AREA OF THE NORTHERN PRETORIA (TSWAING)
METROPOLITAN SUBSTRUCTURE

I, Khabisi Mosunkutu, Member of the Executive Council for Transport and Public Works in the Province of Gauteng, being of the opinion that it is necessary to normalise the situation in the area caused by violence, unrest and instability in the minibus taxi industry, and that it is in the interests of passengers, hereby declare the area of jurisdiction of the Northern Pretoria (Tswaing) Metropolitan Substructure (hereafter called "the declared area") in terms of section 49 (1) of the Gauteng Interim Minibus Taxi-Type Services Act, 1997 (Act No. 11 of 1997) (the Act) to be an area where the special measures provided for in section 49 of the Act are applicable.

I further make regulations in terms of section 49 (7) of the Act, contained in the Schedule hereto.

SCHEDULE

REGULATIONS

- 1. Should the situation in the declared areas not have normalised, the MEC may close one or more or all of the routes and ranks in the declared area to the operation of minibus taxi-type services, or to the operation of such services by means of vehicles using electronic equipment, the installation of which is undesirable in the opinion of the MEC. The routes and ranks will remain closed until the situation has normalised, or until 31 March 2000, whichever is the sooner.
- 2. Should the routes and ranks in the declared area be closed under regulation 1, no person may undertake minibus taxi-type services thereon in contravention of regulation 1 during the period that they remain closed, and any person who does so will commit an offence and will be liable on conviction to imprisonment for a period not exceeding six months or to a fine not exceeding R10 000, or to both a fine and imprisonment.
