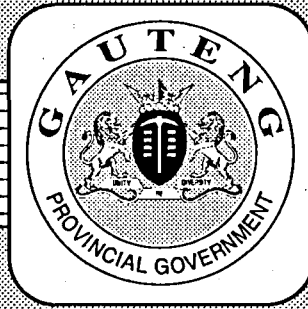

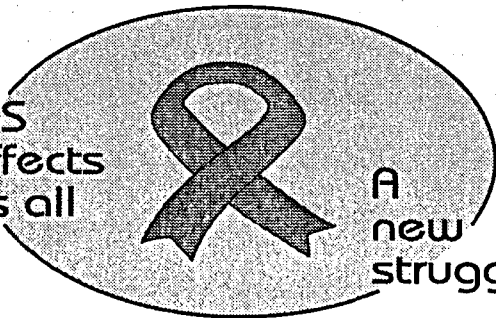

NOTICE 6725 OF 1999

GAUTENG REMOVAL OF RESTRICTIONS ACT, 1996 (ACT 3 OF 1996):
ERVEN 1140, 1141, 1142, 1227, 1228 AND 1229 RYNFIELD TOWNSHIP

It is hereby notified in terms of section 7 (1) of the Gauteng Removal of Restrictions Act, 1996, that the Minister has approved that:

1. Conditions B (c), C (b) to C (d) in Deed of Transfer T21029/1997 and condition 4 (i), (ii), (iii) and (iv) in Deed of Transfer F1037/1938 be removed.

2. Benoni Town-planning Scheme, 1/1947, be amended by the rezoning of Erven 1140, 1141, 1142, 1227, 1228 and 1229 Rynfield to "Special" for shops, bakery, offices, places of refreshment, banks and building societies and such other uses which the local authority may allow subject to certain conditions which amendment scheme will be known as Benoni Amendment Scheme 1/888 as indicated on the relevant Map 3 and scheme clauses which are open for inspection at the office of the Department for Development Planning and Local Government, Johannesburg and Greater Benoni City Council.

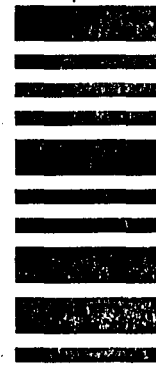

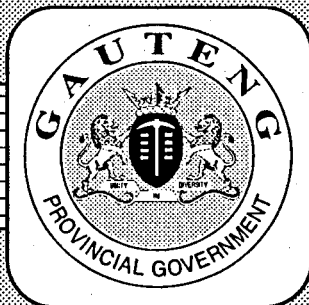

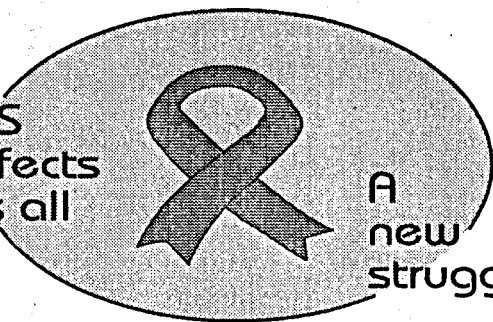

**GAUTENG INTERIM MINIBUS TAXI-TYPE SERVICE ACT, 1997 (ACT NO 11 OF 1997)
(The Act)**

**APPLICATION OF SPECIAL MEASURES IN THE AREA OF THE NORTHERN PRETORIA
(TSWAING) METROPOLITAN SUBSTRUCTURE**

I, Khabisi Mosunkutu, Member of the Executive Council for Transport and Public Works in the Province of Gauteng, make known that having been supplied with information that the situation in the Soshanguve area, which has been declared an area in which the special measures provided for in section 49(1) of the Act will apply as per Notice 6583 of 1999 in Provincial Gazette Extraordinary no. 86 of 29 September 1999, as a result of violence, unrest and instability in the minibus taxi industry, and which situation is continuing, I consider as a matter of urgency, as a result of the said instability in the area, making regulations as set out in the Schedule.

Any person who wishes to make representations in respect of my intended action should do so in writing. Such representations should be addressed to the Community Policing Forums in Soshanguve or any Police Station in the area, or be sent by fax to number 011 355 7304. Such representations should be made on or before 20:00 on Tuesday 5 October 1999.

The reason why I consider making these regulations is because I regard this (as presently advised) as a measure without which other measures to normalise the situation are unlikely to have the desired effect.

SCHEDULE**PROPOSED REGULATIONS**

1. The routes and ranks in the declared area described in regulation 3 below are closed to the operation of minibus taxi-type services for a period of two months from the date of publication of the regulations.
2. No person may undertake minibus taxi-type services on or in a route or rank that has been closed in terms of regulation 1, and any person who does so will commit an offence and will be liable on conviction to imprisonment for a period not exceeding six months or to a fine not exceeding R10 000, or to both a fine and imprisonment.
3. The transfer ranks as referred to in regulation 1 are :
 - Soutpan Section MM
 - Rietgat Taxi Rank
 - Transfer rank

The transfer routes as referred to in regulation 1 are:

- The link between PWV9 (Road P200/1) and Soshanguve
 - Buitekant route and route M17 (Rosslyn – Erasmus road)
 - Soutpan route
