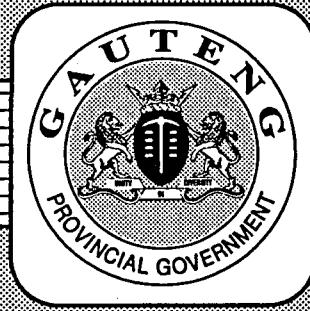

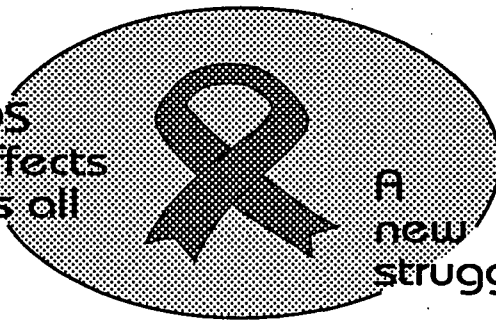

**AMENDMENT OF THE REGULATIONS**  
**REGARDING THE DETERMINATION**  
**OF FEES IN TERMS OF THE ROAD**  
**TRAFFIC ACT, 1989**

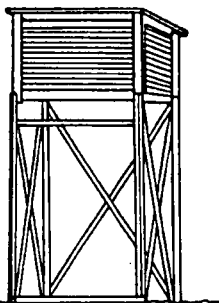
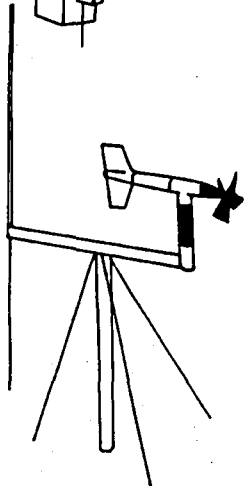
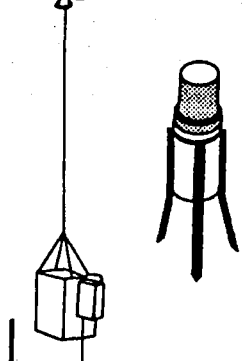
