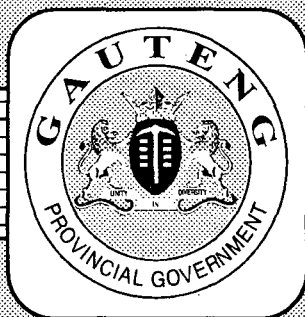

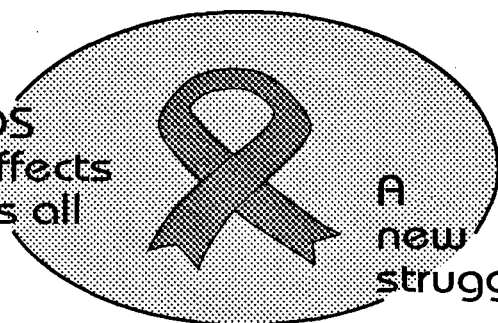

GENERAL NOTICE • ALGEMENE KENNISGEWING**NOTICE 3485 OF 2000****CITY COUNCIL OF PRETORIA****PRETORIA AMENDMENT SCHEME 8055**

It is hereby notified in terms of the provisions of section 57 (1) (a) of the Town-planning and Townships Ordinance, 1986 (Ordinance No. 15 of 1986), that the City Council of Pretoria has approved the amendment of the Pretoria Town-planning Scheme, 1974, being the rezoning of Erf 412, Colbyn, to "Special". The erf shall be used only for the purposes of a office support centre, places of refreshment, conference facilities and a place of entertainment and with the consent of the City Council, clause 18 of the townplanning scheme excluded, for other purposes that in the opinion of the City Council belongs to an office support centre, subject to certain conditions.

Map 3 and the scheme clauses of this amendment scheme are filed with the Chief Executive/Town Clerk of Pretoria and the Director-General: Gauteng Provincial Administration, Community Development Branch, and are open to inspection during normal office hours.

This amendment is known as Pretoria Amendment Scheme 8055 and shall come into operation on 28 July 2000.

KENNISGEWING 3485 VAN 2000**STADSRaad VAN PRETORIA****PRETORIA-WYSIGINGSKEMA 8055**

Hierby word ingevolge die bepalings van artikel 57 (1) (a) van die Ordonnansie op Dorpsbeplanning en Dorpe, 1986 (Ordonnansie No. 15 van 1986), bekendgemaak dat die Stadsraad van Pretoria die wysiging van die Pretoria-dorpsbeplanningskema, 1974, goedgekeur het, synde die hersonering van Erf 412, Colbyn, tot "Spesiaal". Die erf mag slegs gebruik word vir die doeleindes van 'n kantoorondersteuningsentrum, verversingsplekke, konferensiefasiliteite en 'n vermaaklikheidsplek en met die toestemming van die Stadsraad, klousule 18 van die dorpsbeplanningskema uitgesluit, vir enige ander doeleindes wat na die mening van die Stadsraad by 'n kantoorondersteuningsentrum tuis hoort; onderhewig aan sekere voorwaardes.

Kaart 3 en die skemaklousules van hierdie wysigingskema word deur die Uitvoerende Hoof/Stadsklerk van Pretoria en die Direkteur-generaal: Gauteng Provinsiale Administrasie, Tak Gemeenskapsontwikkeling, in bewaring gehou en lê gedurende gewone kantoorure ter insae.

Hierdie wysiging staan bekend as Pretoria-wysigingskema 8055 en tree op 28 Julie 2000 in werking.
