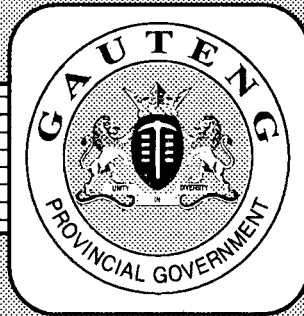

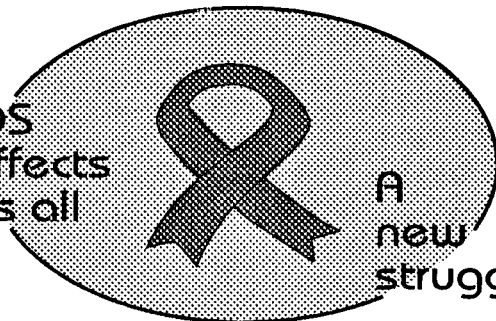

PROPOSED RESTRICTION OF ACCESS FOR SAFETY AND SECURITY PURPOSES AT ELEVATION AVENUE/K-27, RIBOVILLE ROAD/K-27, KING WILLOW CRESCENT/TEAL ROAD AND KING WILLOW CRESCENT/ELEVATION AVENUE OF THE FARM RANDJESFONTEIN 405-JR AND GRAHAM ROAD WEST OF ALLAN ROAD, GLEN AUSTIN AGRICULTURAL HOLDINGS (REGION 2)

Notice is hereby given in terms of Section 45 read with Section 44 of the Rationalisation of Local Government Affairs Act, 1998 (Act No. 10 of 1998) that is the intention of the Randjesfontein Country Estates (Proprietary) Limited to impose restrictions on access for security and safety purposes at: Elevation Avenue/K-27, Riboville Road/K-27, King Willow Crescent/Teal Road; and King Willow Avenue/Elevation Avenue, all at the farm Randjesfontein, 405-JR, and Graham Road/Allan Road in Glen Austin Agricultural Holdings for a period of 2 years from date of this publication.

A sketch plan indicating the locality of the access control point/s as well as the Access Investigation Report will be available for inspection during office hours at the office of the Regional Manager: Corporate Support Services (Regions 1 and 2), Municipal Offices, Sixteenth Road, Randjespark, for a period of 30 (thirty) days from 27 June 2001.

Any person who wishes to comment on the proposed restrictions on access should do so in writing to both the Regional Director, Private Bag X20, Halfway House, 1685, and the undersigned, within 30 (thirty) days from the date hereof, to reach the undersigned not later than 12h00 on 27 July 2001.
