


GAUTENG INTERIM MINIBUS TAXI-TYPE SERVICES ACT, 1997 (ACT No. 11 OF 1997)

UPLIFTMENT OF THE APPLICATION OF SPECIAL MEASURES IN THE TOWNSHIPS OF ORANGE FARM, DRIEZIEK, LAKESIDE AND STREDFORD WITHIN THE AREA OF JURISDICTION OF THE CITY OF JOHANNESBURG METROPOLITAN MUNICIPALITY

I, Khabisi Mosunkutu, Member of the Executive Council for Transport and Public Works in the Province of Gauteng, having made regulations in terms of Section 49 (7) and, having published the regulations and the schedule thereto in *Government Gazette* number 22393 under Notice number 1503 on 15 June 2001, with the intention of closing the taxi ranks and routes as described in Regulations and the schedule thereto, hereby make known that:

- 1. I have supplied with a report and information by the appointed mediator, Mr Thabo Ngobeni that-
 - 1.1 the two taxi Associations operating in area, namely, Imizamo Yethu Taxi Association and Lekang Ka Thata Taxi Association have signed an agreement setting up practical structures and mechanism to ensure discipline and the implementation of their merger agreement,
 - 1.2 violence and instability has subsided and it is now safe to reopen the taxi ranks and routes for the operators and the passengers.
- 2. I hereby make known that-
 - 2.1 I have considered all the facts and reports submitted to me and I have satisfied myself that the situation in the area has normalised,
 - 2.2 the Regulations in terms of Section 49 (7) of the Act and the schedule thereto published in *Government Gazette* number 22393 under Notice number 1503 on 15 June 2001 are hereby uplifted.
 - 2.3 all taxi ranks and routes as described in the regulations referred to in paragraph 2.2 above are opened for minibus taxi-type services with effect from 00h00 on 30 June 2001.
