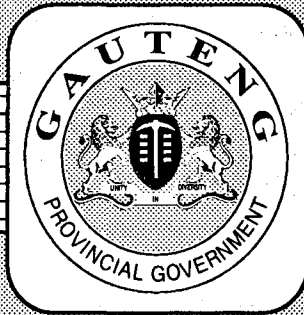

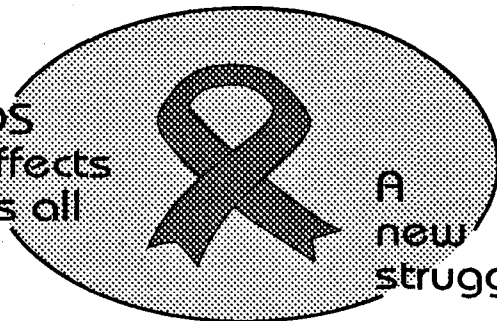

NOTICE 5215 OF 2001
LOCAL GOVERNMENT: MUNICIPAL STRUCTURES ACT, 1998
AMENDMENT OF NOTICE ESTABLISHING THE GREATER EAST RAND METRO (GAUTENG NOTICE No. 6768 OF 2000 AND MPUMALANGA NOTICE No. 309 OF 2000)

In terms of section 16 (1) (b) of the Local Government: Municipal Structures Act, 1998, we, Trevor George Fowler and Mahommed Bhabha, Members of the Executive Councils responsible for local government in the Provinces of Gauteng and Mpumalanga respectively, hereby further amend the notices establishing the Greater East Rand Metro (Gauteng Notice No. 6768 of 2000, as amended, and Mpumalanga Notice No. 309 of 2000, as amended) as set out in the Schedule hereto.

SCHEDULE

Notice No. 6768 of 2000, published in the *Gauteng Provincial Gazette Extraordinary No. 141* dated 1 October 2000, as amended, and Notice No. 309 of 2000 published in the *Mpumalanga Provincial Gazette Extraordinary No. 636* dated 1 October 2000, as amended, are hereby further amended by amending the Schedule thereto as follows:

AMENDMENT OF PART 2
1. Amendment of clause 2

Sub-clause (1) is hereby amended by the substitution for the term "Greater East Rand Metro" of the term "Ekurhuleni Metropolitan Municipality."

GENERAL
2. General Amendment

The term "Greater East Rand Metro" is hereby substituted with the term "Ekurhuleni Metropolitan Municipality" wherever it occurs in the Schedule.
