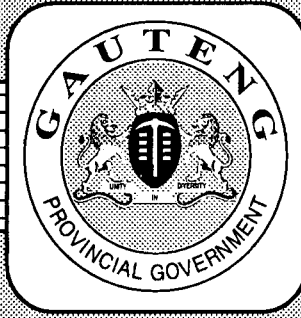

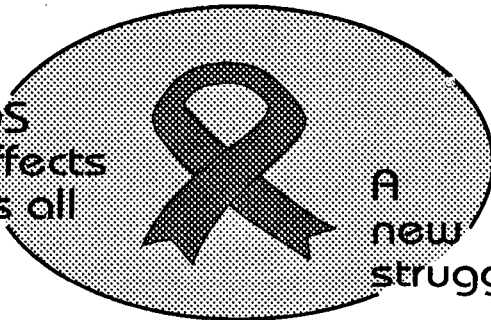

**GENERAL NOTICE**
**NOTICE 5531 OF 2001**

FURTHER EDUCATION AND TRAINING ACT, ACT No. 98 of 1998

**TO DETERMINE THE MANNER IN WHICH OFFICE BEARERS OF AN INTERIM COUNCIL FOR A CLUSTER OF PUBLIC FURTHER EDUCATION AND TRAINING COLLEGES MUST BE ELECTED**

I, Ignatius Patric Jacobs, Member of the Executive Council responsible for Education, in terms of section B (2) of the Further Education and Training Act, No. 98 of 1998; herewith, in the Schedule below, determine the manner in which a chairperson, vice-chairperson and other office bearers of an interim council for a cluster of colleges will be elected.

**Definitions**

In the Schedule, unless the contents indicates otherwise, expressions defined in the Act have the same meaning—

“Act”—means Further Education and Training Act, Act No. 98 of 1998;

“MEC”—means Member of the Executive Council responsible for Education;

“Interim council”—means a council for a cluster of FET colleges as contemplated in Notice No. 5355 of 2001, published in *Provincial Gazette* No. 176 of 5 September 2001;

“cluster”—means a cluster of FET colleges as contemplated in Notice No. 5356 of 2001, published in *Provincial Gazette* No. 176 of 5 September 2001;

“FET”—means Further Education and Training

“quorum”—means when more than 50% of the members of a council is present.

**SCHEDULE**

The members of the interim council for a cluster of FET colleges shall elect from its members, excluding members contemplated in section 8 (3) of the Act, a chairperson, a vice-chairperson and a honorary treasurer—

- (1) under the chairpersonship of a facilitator appointed by the MEC at the first meeting of the interim council and whenever it becomes necessary, to serve for the duration of the interim council;
- (2) the chairperson or vice-chairperson shall only be elected at a meeting where there is a quorum of members;
- (3) each member of the council have one vote for the purpose of the election of each office bearer;
- (4) the facilitator will conduct the elections, by closed ballot, on a fair, open and democratic manner;
- (5) the election of each office bearer will be determined by the majority of votes cast for that specific portfolio.
