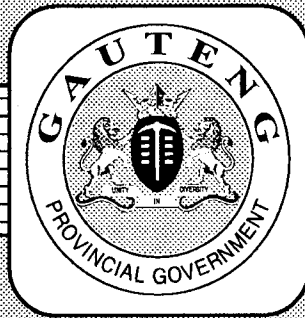

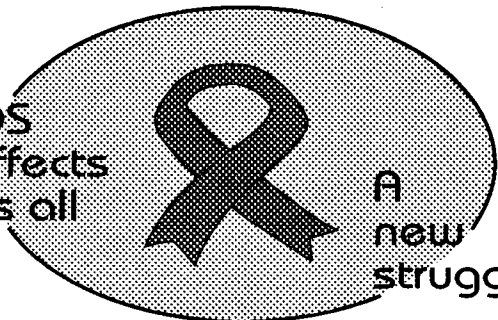

NOTICE OF INTENTION TO ESTABLISH TOWNSHIP BY LOCAL AUTHORITY: PROPOSED LINKSFIELD NORTH EXTENSION 2

The City of Johannesburg (Eastern Metropolitan Local Council) hereby gives notice in terms of section 108(1)(a) of the Town-planning and Townships Ordinance, 1986 (Ordinance 15 of 1986), that it intends establishing a township consisting of the following erven on a part of the Remaining Extent of the farm Bedford 68 - IR:

"Special:" 2 Erven.

Erf 1 and Erf 2: "Special" for dwelling houses/units and related uses, residential buildings including hotels and related uses, public open space, private open space and ancillary uses, offices and related uses, shops and related uses, parking, road purposes, access control and security and buildings ancillary thereto, post boxes and refuse collection points and other uses with the written approval of the Council.
