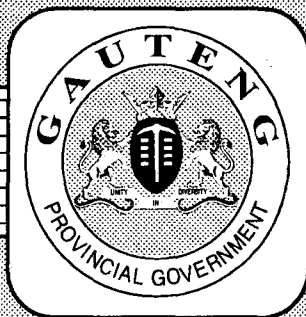

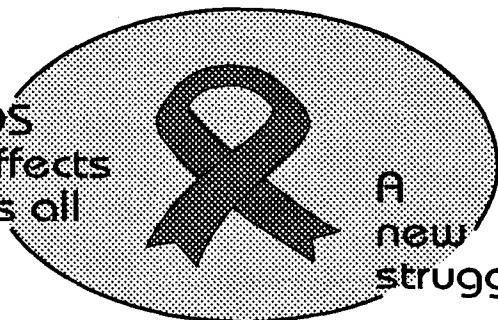

### NOTICE 2225 OF 2001

THE CITY OF TSHWANE METROPOLITAN MUNICIPALITY  
**PRETORIA AMENDMENT SCHEME 8375**

It is hereby notified in terms of the provisions of section 57 (1) (a) of the Town-planning and Townships Ordinance, 1986 (Ordinance No. 15 of 1986), that the City of Tshwane Metropolitan Municipality has approved the amendment of the Pretoria Town-planning Scheme, 1974, being the rezoning of Erf 58 and 59, Menlyn Extension 10 to Special for the purposes of a motor dealership shall be described as an integrated facility that provides a full range of related activities in respect of a specific product line, including a motor workshop, offices, the sale of new spare parts and new cars of that specific product; as well as used cars only within motor showrooms; subject to certain conditions.

Map 3 and the scheme clauses of this amendment scheme are filed with the Acting Municipal Manager and the Director-General: Gauteng Provincial Administration, Community Development Branch, and are open to inspection during normal office hours.

This amendment is known as Pretoria Amendment Scheme 8375 and shall come into operation on the date of publication of this notice.

NOTICE OF REGISTRATION OF TESTING STATION (SECTION 39 OF THE ROAD TRAFFIC ACT, 1996) AND AUTHORITY TO APPOINT EXAMINERS OF VEHICLES (SECTION 3(1)(e) OF THE ROAD TRAFFIC ACT, 1989)

I, Herman Johan Kok, acting Director (Administration) authorized under section 91 read with section 93 of the Road Traffic Act, 1996, (Act No. 93 of 1996)—

(1) hereby give notice in terms of section 39 of the Road Traffic Act, 1996, of the registration of Bosjak Zoom CC t/a Edenvale Private Test Station with infrastructure number 49511317 as a B-Grade testing station and;

(2) hereby determine under section 3(1)(e) of the Road Traffic Act, 1989, Bosjak Zoom CC t/a Edenvale Private Test Station with infrastructure number 49511317 to be an authority which may appoint a person as an examiner of vehicles, on conditions that—
