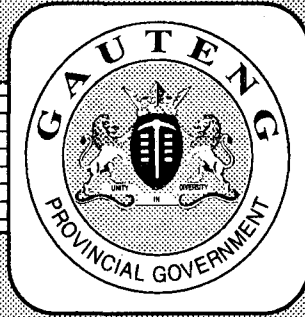

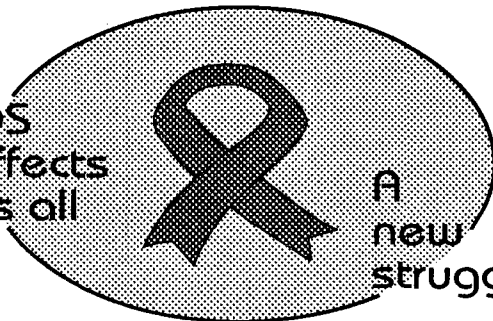

NOTICE OF REGISTRATION OF TESTING STATION (SECTION 39 OF THE ROAD TRAFFIC ACT, 1996) AND AUTHORITY TO APPOINT EXAMINERS OF VEHICLES [SECTION 3 (1) (e) OF THE ROAD TRAFFIC ACT, 1989]

I, Herman Johan Kok, acting Director (Administration) authorized under section 91 read with section 93 of the Road Traffic Act, 1996 (Act No. 93 of 1996)—

(1) hereby give notice in terms of section 39 of the Road Traffic Act, 1996, of the registration of Moor Test Centre CC with infrastructure number 49511347 as a B-Grade Test Centre; and

(2) hereby determine under section 3 (1) (e) of the Road Traffic Act, 1989, Moot Test Centre CC with infrastructure number 49511347 to be an authority which may appoint a person as an examiner of vehicles, on condition that—

(a) such a person has obtained a diploma in the examination for examiners of vehicles at a centre approved by the Minister of Transport; and

(b) appointment takes place subject to the condition that vehicles may only be examined at Moot Test Centre CC.
