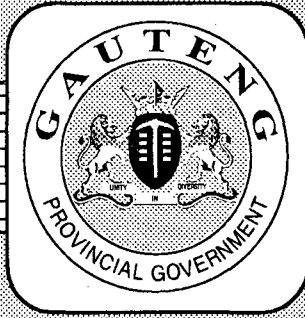

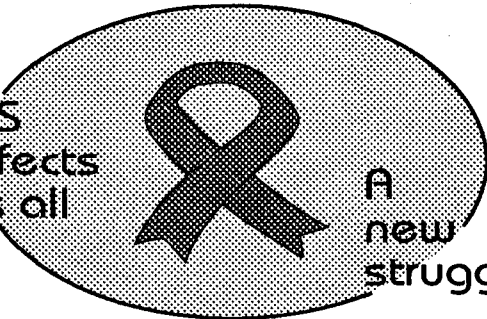

NOTICE 3385 OF 2001

CORRECTION NOTICE: RANDPARKRIF EXTENSION 93

The Northern Metropolitan Local Council of Greater Johannesburg Metropolitan Council, herewith gives notice that Local Authority Notice 2653 dated 9 May 2001 has been amended as follows:

- (a) By the deletion in the English and Afrikaans notices of clause 1(6) and the renumbering of clauses 1(7), 1(8), 1(9) and 1(10) respectively to 1(6), 1(7), 1(8) and 1(8) respectively.
- (b) By the substitution in the English notice of clause 2(2) for the following:

"(2) ERVEN 4364, 4365 AND 4366

The erven shall be subject to temporary servitudes of right of way, 4 m wide and as indicated on the General Plan, in favour of the Residents Association(s) to be established in respect of the township. The servitudes may be cancelled with the written consent of the local authority."

- (c) By the substitution in the Afrikaans notice of clause 2(2) for the following:

"(2) ERWE 4364, 4365 EN 4366
