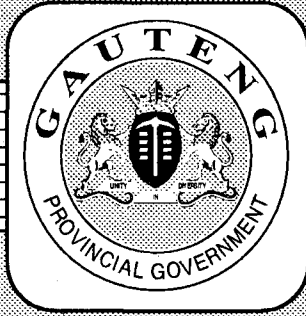

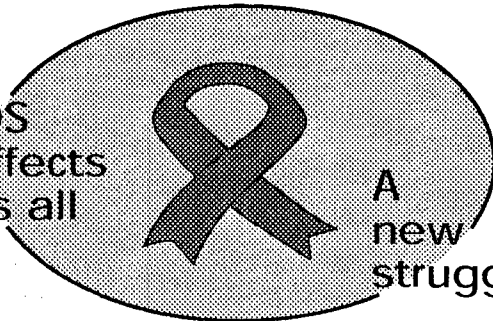

CITY OF JOHANNESBURG

JOHANNESBURG AMENDMENT SCHEME 1508E

It is hereby notified in terms of section 57 (1) of the Town-planning-scheme and Townships Ordinance, 1986, that the City of Johannesburg approved the amendment of the Johannesburg Town-Planning Scheme, 1979, by rezoning of Erf 1940 Houghton Estate, from "Residential 1", permitting offices in the existing structures, subject to conditions to "Special" permitting a filling station and ancillary uses such as a convenience store, a car wash facility and automatic banking teller machines, subject to conditions.

Copies of the approved application are filed with the Executive Director, Development Planning, Transportation and Environment, at 158 Loveday Street, Braamfontein, and are open for inspection at all reasonable times.

This amendment is known as Sandton Amendment Scheme 1508E and shall come into operation 56 days after date of publication hereof.
