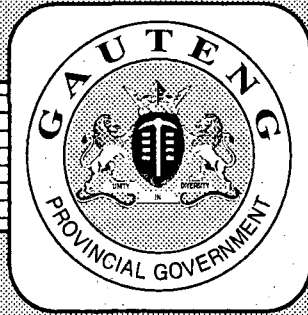

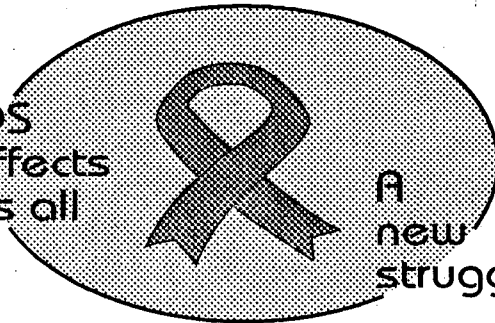

DECLARATION AS APPROVED TOWNSHIP: BARTLETT EXTENSION 37 TOWNSHIP

Notice is hereby given in terms of section 80 of the Town-planning and Townships Ordinance, 1986, read with section 95 of the said Ordinance that whereas certain errors and/or omissions occurred in Local Authority Notice 206 dated 14 February 2002, the notice is hereby amended as follows:

- (a) By the deletion of condition 2.1 (e) in both the English and Afrikaans text of the notice.
- (b) By the insertion of the following condition 2.2 in the English text of the notice:
 2.2 ALL ERVEN EXCEPT ERVEN 275 AND 276 (PRIVATE ROAD)
 The erf is entitled to a right-of-way servitude over Erf 276 (private road) in the township.
- (c) By the insertion of the following condition 2.2 in the Afrikaans text of the notice.
 2.2 ALLE ERWE UITSLUITEND ERWE 275 EN 276 (PRIVAAT PAD)
 Die erf is geregtig op 'n reg-van-weg serwituut oor Erf 276 (privaat pad) in die dorp.
- (d) By the renumbering of conditions 2.2 and 2.3 to 2.3 and 2.4 respectively.
