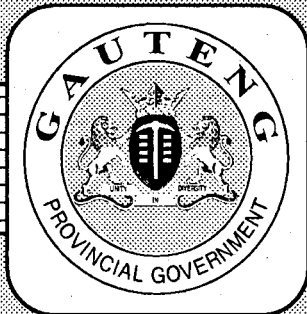

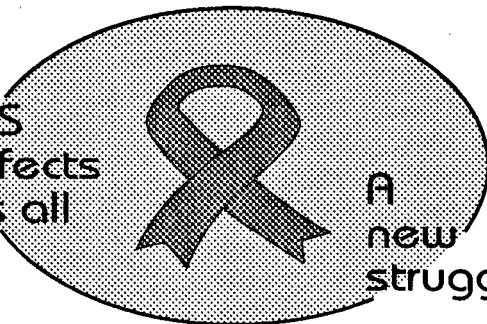

PROPOSED CLOSURE AND ALIENATION OF PART OF EMFULeni DRIVE, VANDERBIJL PARK SOUTH EAST 3 TOWNSHIP

Notice is hereby given in terms of Sections 67, 68 and 79 (18) of the Local Government Ordinance, 1939 (Ordinance 17 of 1939) as amended, that it is the intention of the Emfuleni Local Municipality to close permanently and alienate part of Emfuleni Drive, Vanderbijl Park South East 3 Township, in extent of approximately 1,12 hectares. The Council intends to close the part of the road permanently which will be incorporated in the proposed Emfuleni Golf Estate development.

A plan indicating the position of the boundaries of the portion and the Council resolution and conditions in respect of the proposed closing and alienation of the property, are open to inspection during normal office hours at the office of Me A Streak, Room 16, Municipal Offices, Beaconsfield Avenue, Vereeniging, during normal office hours, and enquiries may be made at telephone (016) 450 3149.
