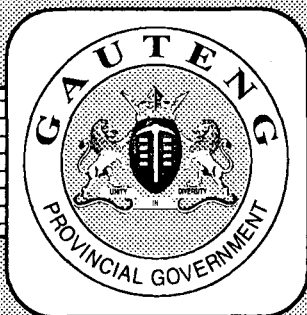

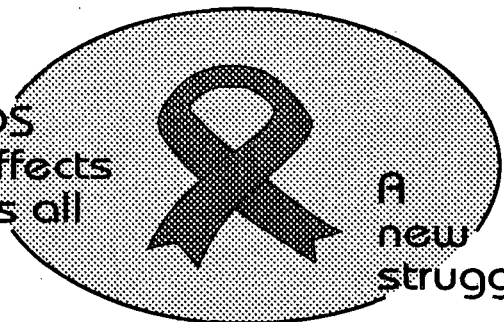

GAUTENG INTERIM MINIBUS TAXI-TYPE SERVICES REGULATIONS

I, Khabisi Mosunkutu, Member of the Executive Council for Public Transport, Roads and Works in the Province of Gauteng, hereby make Regulations in the Schedule to this Notice in terms of Section 38 (3) of the Gauteng Interim Minibus Taxi-Type Services Act 1997 (Act No. 11 of 1997) (the Act).

- SCHEDULE -**PRESCRIBED NOTICE IN TERMS OF SECTION 38 (3)****1. The Board must give a written notice containing the following:**

- (a) reference to the relevant sections of the Act;
- (b) the intended action;
- (c) the time that the action will come into effect;
- (d) the duration of the action;
- (e) the period of notice to the affected permit holders which may not be less than two days from the publication of the notice in the newspaper;
- (f) the affected areas;
- (g) the names of the affected permit holders; and
- (h) the reference numbers of the affected permits.

2. The above notice must be:

- (a) published in the Provincial Gazette;
- (b) published in a popularly read newspaper in each of the affected areas;
- (c) sent by registered mail to the relevant taxi council; and
- (d) sent by registered mail to the relevant metropolitan and district councils / municipality.
