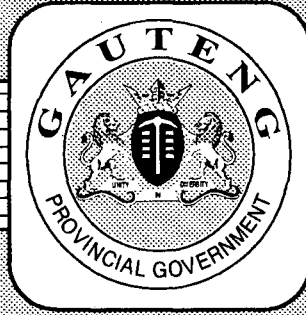

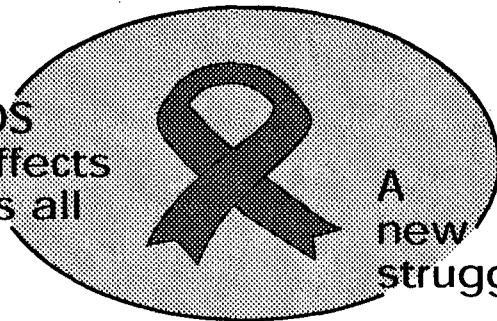

**ESTABLISHMENT OF MUNICIPAL POLICE SERVICE  
IN TERMS OF SECTION 64A(4) OF  
THE SOUTH AFRICAN POLICE SERVICE ACT, 1995  
(ACT NO. 68 OF 1995)**

By virtue of the powers vested in me by section 64A(4) of the South African Police Service Act, 1995 (Act No. 68 of 1995), I, **Mrs. Nomvula Paula Mokonyane**, MEC for Safety and Liaison of **Gauteng Province**, hereby establish a municipal police service to be known as the **Ekurhuleni Metropolitan Police Department**, for the area of jurisdiction of **Ekurhuleni Metropolitan Council**, subject to the following conditions:-

- (i) That the Ekurhuleni Metropolitan Council and Ekurhuleni Metropolitan Police Department shall not, in respect of any aspect referred to in Reg 1(2)(b) & (c) of the Regulations for Municipal Police Service without prior written approval of the MEC for Safety and Liaison, deviate from or act contrary to the resolutions and representations made in the application and annexures by the Ekurhuleni Metropolitan Council for the establishment of the Ekurhuleni Metropolitan Police Department; and
- (ii) That the Ekurhuleni Metropolitan Police Department shall uphold and safeguard the fundamental rights of all persons and property within the jurisdiction of the Ekurhuleni Metropolitan Council, as guaranteed by Chapter 3 of the Constitution of the Republic of South Africa.

- (i) That the Tshwane Metropolitan Council and Tshwane Metropolitan Police Department shall not, in respect of any aspect referred to in Reg 1(2)(b) & (c) of the Regulations for Municipal Police Service without prior written approval of the MEC for Safety and Liaison, deviate from or act contrary to the resolutions and representations made in the application and annexures by the Tshwane Metropolitan Council for the establishment of the Tshwane Metropolitan Police Department; and
- (ii) That the Tshwane Metropolitan Police Department shall uphold and safeguard the fundamental rights of all persons and property within the jurisdiction of the Tshwane Metropolitan Council, as guaranteed by Chapter 3 of the Constitution of the Republic of South Africa.
