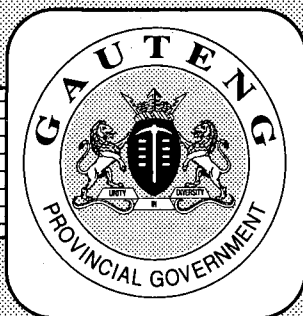

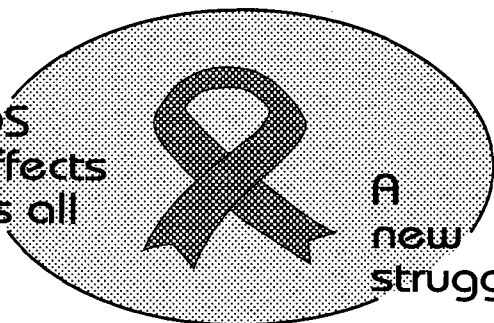

### LOCAL AUTHORITY NOTICE 709

#### CITY OF TSHWANE METROPOLITAN MUNICIPALITY

#### NOTICE OF A DRAFT SCHEME

The CITY OF TSHWANE METROPOLITAN MUNICIPALITY hereby give notice in terms of section 28 (1) (a), read with section 55, of the Town-planning and Townships Ordinance, 1986 (Ordinance No. 15 of 1986), that a draft town-planning scheme to be known as Pretoria Amendment Scheme 9316, has been prepared by it. This scheme is an amendment of the Pretoria Town-planning Scheme, 1974, and comprises the rezoning of Celeste Street and a portion of Generaal Louis Botha Avenue (now known as Erven 848 and 849) Waterkloof Glen Extension 5, from Existing Streets to "Special" for the purpose of motor dealerships, a place of refreshment including take-aways and drive through facilities; subject to certain conditions;

The draft scheme is open for inspection during normal office hours at the office of the Executive Director: City Planning and Development, Land Use Rights Division, Room 401, Fourth Floor, Munitoria building, c/o Van Der Walt Street and Vermeulen Street, Pretoria within a period of 28 days from 29 Mei 2002 (the date of first publication of this notice).

Objections to or representations in respect of the scheme must be lodged with in writing with the Executive Director at the above address or at P O Box 3242, Pretoria, 0001 within a period of 28 days from 29 Mei 2002 provided that, should claims and/or objections be sent by mail, such claims and/or objections must reach the Council before or on the aforementioned date.
