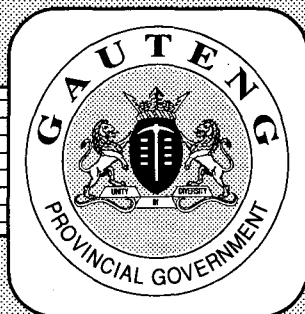

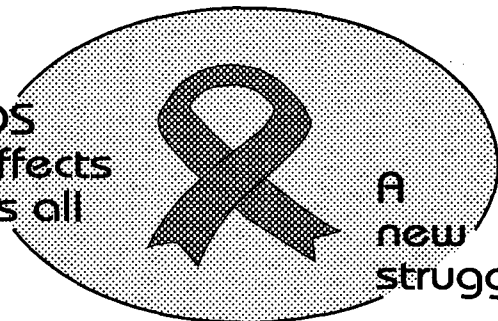

CORRECTION NOTICE**CORRECTION OF REGULATION 3(4)(a) and (d) OF THE GAUTENG PROVINCIAL
ROAD TRAFFIC REGULATIONS, 2001**

The Member of the Executive Council responsible for road traffic regulation in the Gauteng Province has under section 25 of the Gauteng Provincial Road Traffic Act, 1997 (Act No. 10 of 1997), made the following corrections to the Gauteng Provincial Road Traffic Regulations, 2001, as published in General Notice 3845 of 2001 (*Provincial Gazette Extraordinary* no. 119 of 29 June 2001):


(a) Regulation 3(4)(a) is corrected as follows:

"3(4)(a) A registering authority must receive a refund of 100% on fees collected under items 1, 2, 3, 6, 7, 9(a), 11, 13, 15, 16, 18, 19, 20, 21(b), 22(b), 23, [23(b), 24] and 31 [32] of Schedule 1 and item 5 of Schedule 2 to these regulations;"

(b) Regulation 33(4)(d) is corrected as follows:

"3(4)(d) the municipality which is the appropriate registering authority must be refunded at a rate of 15% of the fee provided for in item 22(a) [~~23(a)~~] of Schedule 1 to these regulations."
