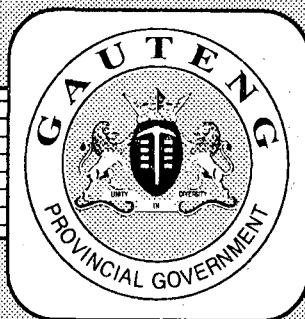

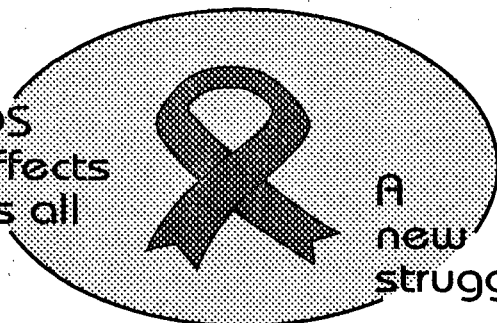

### EKURHULENI METROPOLITAN MUNICIPALITY

#### PROCLAMATION OF A ROAD

We, Trevor George Fowler and Mohammed Bhabha, Members of the Executive Councils responsible for Local Government in the Province of Gauteng and Mpumalanga respectively, by the power vested in us by section 4 of the Local Authorities Roads Ordinance, 1904, hereby proclaim the road as prescribed in the Schedule hereto as a public link road, under the jurisdiction of Ekurhuleni Metropolitan Municipality.
