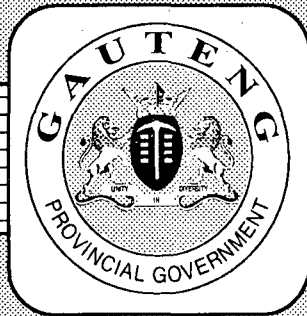

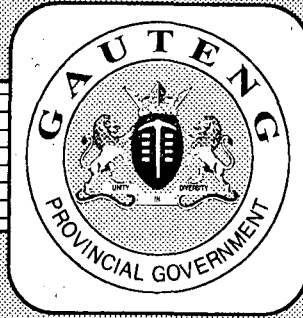

AMENDMENT SCHEME 6385**

It is hereby notified in terms of section 57 (1) of the Town Planning and Townships Ordinance, 1986, that the City of Johannesburg approved the amendment of the Johannesburg Town Planning Scheme, 1979, by the rezoning of Erf 976 Greenside Extension 1, from "Residential 1" to "Residential 1" including offices as a consent use right subject to certain conditions.

Copies of the application as approved are filed with the offices of the Executive Director: Development Planning, Transportation and Environment, 158 Loveday Street, Braamfontein, 8<sup>th</sup> Floor, A Block, Civic Centre, and are open for inspection at all reasonable times.

This amendment is known as Johannesburg Amendment Scheme 6385 and shall come into operation within a period of 56 days of publication hereof.
