



CITY OF TSHWANE METROPOLITAN MUNICIPALITY

DECLARATION OF MAGALIESKRUIN EXTENSION 33 AS APPROVED TOWNSHIP

In terms of section 103 of the Town-planning and Townships Ordinance, 1996 (Ordinance No 15 of 1986), the City of Tshwane Metropolitan Municipality hereby declares the Township of **Magalieskruin Extension 33** to be an approved township, subject to the conditions set out in the Schedule hereto.

SCHEDULE

CONDITIONS UNDER WHICH THE APPLICATION MADE BY GOLDEN LANE ESTATES (PTY) LTD, HEREINAFTER REFERRED TO AS THE APPLICANT/TOWNSHIP OWNER UNDER THE PROVISIONS OF THE TOWN PLANNING AND TOWNSHIP ORDINANCE, 1986 (ORDINANCE NO 15 OF 1986), FOR PERMISSION TO ESTABLISH A TOWNSHIP ON THE REMAINDER OF PORTION 251 OF THE FARM HARTEBEESTFONTEIN 324-JR HAS BEEN GRANTED

1. CONDITIONS OF ESTABLISHMENT

- 1.1 **Name:** The name of the township shall be Magalieskruin Extension 33.
- 1.2 **Design:** The township shall consist of erven and streets as indicated on General Plan SG No 8989/1996.

1.3 **Disposal of existing conditions of title:**

All erven shall be made subject to existing conditions and servitudes, if any, including the reservation or rights to minerals.

1.4 **Endowment**

Payable to the City of Tshwane Metropolitan Municipality.

The township owner shall pay the City of Tshwane Metropolitan Municipality as endowment the total amount of R 58 000-00, which amount shall be used by the City of Tshwane Metropolitan Municipality for the acquisition of land for park and/or public open space purposes.

The said endowment amount shall be payable in accordance with the provisions of Section 81 of the Town Planning and Townships Ordinance, 1986 (Ordinance 15 of 1986).

1.5 **Removal of replacement of Municipal Services**

Should it become necessary to move or replace any existing municipal services as a result of the establishment of the township, the cost thereof shall be borne by the township owner.

1.6 **Demolition of buildings and structures**

When required by the City of Tshwane Metropolitan Municipality to do so, the township owner shall at his own expense cause to be demolished to the satisfaction of the City of Tshwane Metropolitan Municipality all existing buildings and structures situated within building line reserves and side spaces or over common boundaries, or dilapidated structures.

1.7 **Removal of Litter**

The township owner shall at his own expense have all litter within the township area removed to the satisfaction of the City of Tshwane Metropolitan Municipality, when required to do so by the City of Tshwane Metropolitan Municipality.

1.8 Removal and/or replacement of Eskom Power Lines

Should it become necessary to move or replace any existing power lines of Eskom as a result of the establishment of the township, the cost thereof shall be borne by the township owner.

1.9 Removal and/or replacement of Telkom Services

Should it become necessary to move or replace any existing Telkom services as a result of the establishment of the township, the cost thereof shall be borne by the township owner.

1.10 Consolidation of erven

Erven 768, 169 and 770 shall be consolidated and developed as a single development. The City of Tshwane Metropolitan Municipality hereby consent to the consolidation of the said erven.

2. CONDITIONS OF TITLE

The erven mentioned below shall be subject to the conditions as indicated, imposed by the City of Tshwane Metropolitan Municipality, in terms of the provisions of the Town Planning and Townships Ordinance, 1986. (Ordinance 15 of 1986).

2.1 All Erven:

- (a) The erf shall be subject to a servitude, 2m wide, for municipal services (water/sewage/electricity/stormwater)(hereafter "the services"), in favour of the Local Authority, along any two boundaries excepting a street boundary and, in the case of a panhandle erf, an additional servitude for municipal purposes 2m wide over the access portion of the erf, if and when required by the Local Authority; Provided that the Local Authority may waive any such servitude.
- (b) No buildings or other structures may be erected within the aforesaid servitude area and no trees with large roots may be planted within the area of such servitude or within a distance of 2m thereof.
- (c) The City of Tshwane Metropolitan Municipality shall be entitled to deposit temporarily on the land adjoining the aforesaid servitude any material as excavated during the laying, maintenance or removal of such sewerage mains and other works which in its discretion it regards necessary and further more the City of Tshwane Metropolitan Municipality shall be entitled to reasonable access to the said property for the aforesaid purpose subject to the provision that the City of Tshwane Metropolitan Municipality shall make good any damage caused during the process of the laying, maintenance or removal of such services mains and other works.

STAAT VAN VOORWAARDES WAAROP DIE AANSOEK GEDOEN DEUR GOLDEN LANE ESTATES BK, HIERNA VERWYS AS DIE AANSOEKER / DORPSEIENAAR, INGEVOLGE DIE BEPALINGS VAN HOOFSTUK III VAN DIE ORDONNANSIE OP DORPSBEPLANNING EN DORPE, 1986 (ORDONNANSIE 15 VAN 1986), OM TOESTEMMING OM 'N DORP TE STIG OP DIE RESTANT VAN GEDEELTE 251 VAN DIE PLAAS HARTEBEESTFONTEIN 324-JR, TOEGESTAAN IS

1. STIGTINGSVOORWAARDES

- 1.1 **Naam:** Die naam van die dorp is **Magalieskruin Uitbreiding 33**.
- 1.2 **Ontwerp:** Die dorp bestaan uit erwe en strate soos aangedui op Algemene Plan S.G. No. 8989/1996..
- 1.3 **Beskikking oor bestaande titelvoorwaardes:**
Alle erwe moet onderworpe gemaak word aan bestaande titelvoorwaardes as daar is, met inbegrip van die voorbehoud van regte op minerale.
- 1.4 **Begiftiging**
Betaalbaar aan die Stad van Tshwane Metropolitaanse Munisipaliteit.
Die dorpseienaar moet aan die Stad van Tshwane Metropolitaanse Munisipaliteit, as begiftiging, 'n totale bedrag van R 58 000-00 betaal, welke bedrag dur die Stad van Tshwane Metropolitaanse Munisipaliteit aangewend moet word vir die verkryging van grond vir park- en/of openbare oopruimte doeleindes.
Die genoemde begiftigingsbedrag is betaalbaar kragtens die bepalings van Artikel 81 van die Ordonnansie op Dorpsbeplanning en Dorpe, 1986 (Ordonnansie 15 van 1986).
- 1.5 **Verskuiwing en/of verwydering van munisipale dienste**
Indien dit as gevolg van die stigting van die dorp nodig word om enige bestaande munisipale dienste te verskuif of te vervang, moet die koste daarvan deur die dorpseienaar gedra word.
- 1.6 **Sloping van geboue en strukture**
Die dorpseienaar moet op eie koste alle bestaande geboue en strukture wat binne boulynreserwes en kantruimtes of oor gemeenskaplike grense geleë is, of bouvallige strukture laat sloop tot tevredenheid van die Stad van Tshwane Metropolitaanse Munisipaliteit wanneer die Stad van Tshwane Metropolitaanse Munisipaliteit dit vereis.
- 1.7 **Verwydering van rommel**
Die dorpseienaar moet op eie koste alle rommel binne die dorpsgebied laat verwijder tot tevredenheid van die Stad van Tshwane Metropolitaanse Munisipaliteit wanneer die Stad van Tshwane Metropolitaanse Munisipaliteit dit vereis.
- 1.8 **Verskuiwing en/of verwydering van Eskom Kraglyne**
Indien dit as gevolg van die stigting van die dorp nodig word om enige bestaande kraglyne van Eskom te verskuif, moet die koste daarvan deur die dorpseienaar gedra word.

1.9 Verskuiwing en/of verwydering van Telkom Dienste

Indien dit as gevolg van die stigting van die dorp nodig word om enige bestaande dienste van Telkom te verskuif en/of te verwyder moet die koste daarvan deur die dorpseienaar gedra word.

1.10 Konsolidasie van erwe

Erwe 768, 769 en 770 sal gekonsolideer en ontwikkel word as 'n enkele ontwikkeling. Die Stad van Tshwane Metropolitaanse Munisipaliteit gee hiermee toestemming vir die konsolidasie van die gemelde erwe.

2. TITELVOORWAARDES

Die erwe hieronder genoem, is onderworpe aan die voorwaardes, soos aangedui, opgeleë deur die Stad van Tshwane Metropolitaanse Munisipaliteit ingevolge die bepalings van die Ordonnansie op Dorpsbeplanning en Dorpe, 1986 (Ordonnansie No 15 van 1986):

2.1 Alle erwe

- (a) Die erf is onderworpe aan 'n serwituit, 2m breed, vir munisipale dienste (water / riol / elektrisiteit / stormwater) (hierna "die dienste", genoem), ten gunste van die Stad van Tshwane Metropolitaanse Munisipaliteit, langs enige twee grense, uitgesonderd 'n straatgrens en, in die geval van 'n pypsteelerf, 'n addisionele serwituit vir munisipale doeleinades 2m breed oor die toegangsgedeelte van die erf, indien en wanneer die plaaslike bestuur dit verlang: Met dien verstande dat die plaaslike bestuur van sodanige serwituit mag afsien.
- (b) Geen geboue of ander strukture mag binne die voornoemde serwituitgebied opgerig word nie en geen grootwortelbome mag binne die gebied van sodanige serwituit of binne 2m daarvan geplant word nie.
- (c) Die Stad van Tshwane Metropolitaanse Munisipaliteit is geregtig om enige materiaal wat deur hom uitgegrawe word tydens die aanleg, onderhou of verwydering van sodanige riolhoofpypeleidings- en ander werke wat hy volgens goedgunke noodsaklik ag, tydelik te plaas op die grond wat aan die voornoemde serwituit grens en voorts is die Stad van Tshwane Metropolitaanse Munisipaliteit geregtig op redelike toegang tot genoemde grond vir die voornoemde doel, onderworpe daaraan dat die Stad van Tshwane Metropolitaanse Munisipaliteit enige skade vergoed wat gedurende die aanleg, onderhou of verwydering van sodanige dienste en ander werke veroorsaak word.




