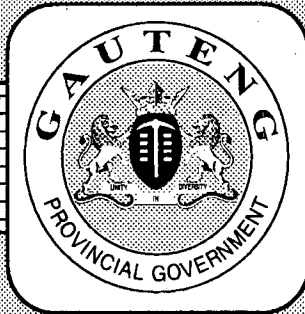

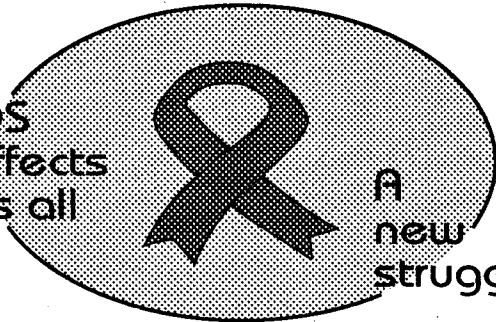

## LOCAL AUTHORITY NOTICE

### LOCAL AUTHORITY NOTICE 1100

#### EKURHULENI METROPOLITAN MUNICIPALITY

#### BOKSBURG SERVICE DELIVERY CENTRE

#### CORRECTION NOTICE: DECLARATION AS APPROVED TOWNSHIP: RAVENSWOOD EXTENSION 49 TOWNSHIP

Notice is hereby given in terms of section 80 of the Town-planning and Townships Ordinance, 1986, read with section 95 of the said ordinance that whereas certain errors and/or omissions occurred in Local Government Notice 740 dated 31 May 2002, the notice is hereby amended as follows:

(a) By the amendment of condition 1.5 in the English text of the notice to read as follows:

#### 1.5 DISPOSAL OF EXISTING CONDITIONS OF TITLE

All erven shall be made subject to existing conditions of title and servitudes, if any, including the reservation of rights to minerals, but excluding—

(a) the following servitude which affects a street in the township only:

A servitude 3,31 metres wide for road widening purposes all along and parallel to the western boundary of the properties, in favour of the local authority, which servitudes are indicated by figures ABEHA and HEFG on diagram SG No A 6675/1993 annexed to Deed of Servitude K1501/1994.

(b) The following servitude which is effectively dealt with under 2.1 (a) below and which must therefore not be passed on to the erven in the township:

The property is subject to a servitude in favour of the local authority two metres wide for sewerage and other municipal purposes along any two boundaries thereof excluding a road boundary.

(b) By the amendment of condition 1.5 in the Afrikaans text of the notice to read as follows:
