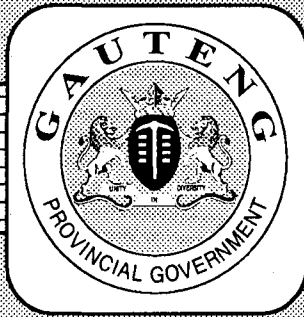

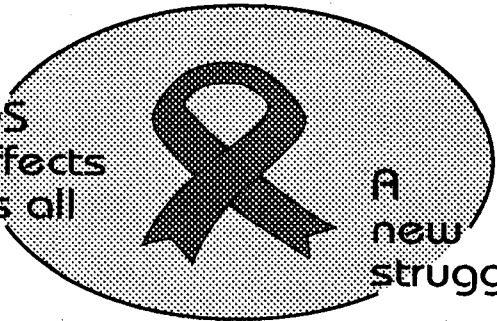

**CITY OF JOHANNESBURG
REMOVAL OF RESTRICTION ACT, 1996 (Act No 3 of 1996)**

It is hereby notified in terms of section 6 (8) of the Removal of Restriction Act, 1996, that the City of Johannesburg has approved that;

- 1) Condition (n) from Deed of Transfer T78036/90 be removed; and
- 2) Sandton Town Planning Scheme, 1980, amended by the rezoning of Erf 117 Morningside Extension 20 from "Residential 1" to "Residential 1" permitting three dwellings units on the site, which amendment scheme will be known as Sandton Amendment Scheme 13/0182 as indicated on the approved application which are open for inspection at the office of the Department of Development Planning, Transportation and Environment.
- 3) Sandton Amendment Scheme 13/0182 will come into operation on the date of publication hereof
