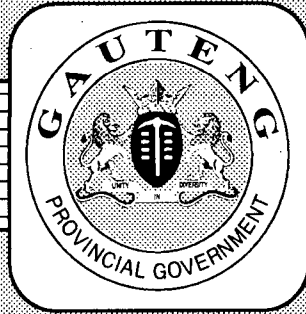

It is hereby notified in terms of section 57 (1) of the Town Planning and Townships Ordinance, 1986, that the City of Johannesburg approved the amendment of the Sandton Town Planning Scheme, 1980, by rezoning Erf 989, Paulshof Extension 54 from "Undetermined" to "Residential 2".
