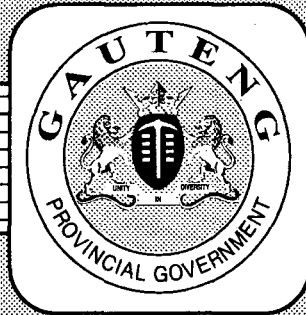

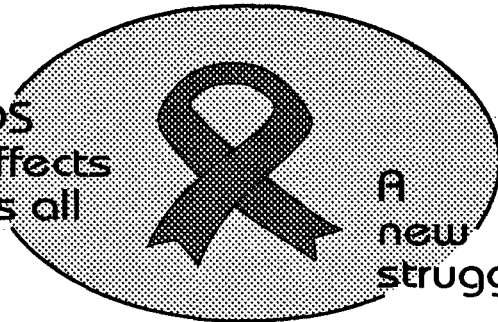

Notice No. 6766 of 2000, published in *Provincial Gazette Extraordinary* No. 141 dated 1 October 2000, as amended, are hereby further amended by amending the Schedule thereto as follows:

AMENDMENT OF PART 6

1. *Amendment of clause 24*

Clause 24 is hereby amended—

(i) by the substitution for sub-clause (4) of the following sub-clause:

“(4) The employment of staff by the City of Johannesburg Metropolitan Municipality in terms of sub-clause (3) must be effected in accordance with section 14 (3) (a) (i) and (ii) of the Local Government: Municipal Structures Act, 1998; and

(ii) by the deletion of subclause 5”.
