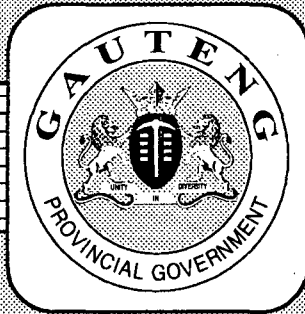

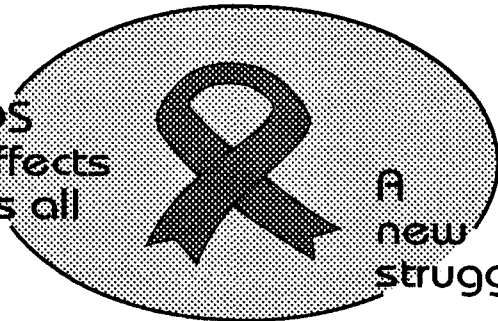

GAUTENG INTERIM MINIBUS TAXI-TYPE SERVICES ACT 1997(ACT NO. 11 OF 1997)

NOTICE OF INTENTION TO MAKE REGULATIONS TO CLOSE TAXI ROUTES AND RANKS IN TERMS OF SECTION 49 (7) OF THE ACT IN THE AREA OF JURISDICTION OF THE CITY OF JOHANNESBURG METROPOLITAN MUNICIPALITY.

I, Khabisi Mosunkutu, Member of the Executive Council for Public Transport, Roads and Works in the Province of Gauteng, having already declared the area of the **City of Johannesburg Metropolitan Municipality** as an area where it is, in my opinion, necessary to normalise the situation caused by violence, unrest and instability in the taxi industry and that it is in the interest of passengers and as the situation is still abnormal and as the closure of routes and rank as mentioned hereinafter is in my opinion absolutely necessary to normalise the situation. I now give notice of my intention to make regulations in terms of section 49 (7) of the Act to close the routes and ranks as fully described in the schedule hereto.

SCHEDULE

The following taxi routes and ranks specified below leading to Meadowlands Zones 1-10 only, will be closed to Minibus Taxi-Type Services.

1.1 Routes

1.1.1 All Meadowlands Zones 1-10 Routes to Johannesburg Taxi Ranks

All routes leading to Johannesburg from Meadowlands Zones 1 to 10 areas

1.1.2 Phefeni Routes near Meadowlands to Johannesburg Taxi Ranks

All routes leading to Johannesburg from Meadowlands-Phefeni area

1.1.3 Mzimhlophe Routes to Johannesburg Taxi Ranks

All routes leading to Johannesburg from Mzimhlophe Meadowlands area

1.2 Ranks

1.2.1 All Meadowlands Zones 1-10 Taxi Ranks: situated within the boundaries of Meadowlands Zone 1-10 Township

1.2.2 Phefeni Taxi Ranks: situated near Meadowlands Township area

1.2.3 Mzimhlophe Taxi Ranks: situated within the boundaries of Meadowlands

1.2.4 Jeppe Station Taxi Rank: situated at John Page Street

1.2.5 Nugget Street Taxi Ranks: situated at Nugget Street between Market and Anderson Streets

1.2.6 Biccard Street Taxi Rank: situated between Biccard and Simmonds Streets at Braamfontein area

1.2.7 Booyens Taxi Rank: situated at Ophir Booyens Road, Frazer and Mentz Streets

1.2.8 The Bridge Taxi Rank: situated at Noord / Wanderers and King George Streets

1.2.9 Fordsburg Taxi Rank: situated on the grounds of Oriental Plaza at Main Road, corners of High & Commercial Roads, Pine Avenue and Avenue Road

1.2.10 The illegal Taxi Rank mentioned below:

1.2.10.1 Pim / West Street situated at the corner of Pim and West Streets

2. The duration of the closure of the taxi routes named above will be determined by reports and information received indicating that the situation has stabilised and that the security situation of participants in the taxi industry as well as passengers has been stabilised.
