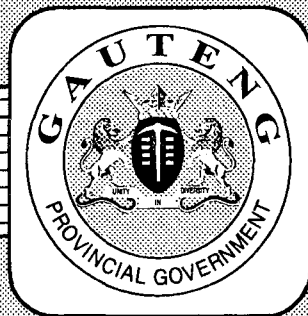

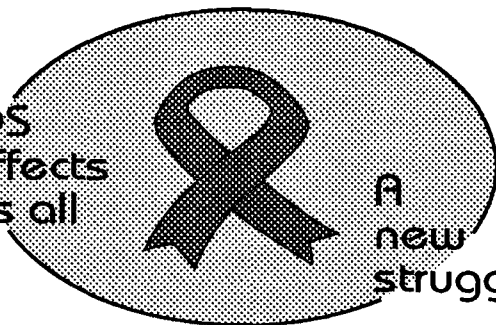

AMENDMENT SCHEME 01-0428

It is hereby notified in terms of section 57 (1) of the Town Planning and Townships Ordinance, 1986, that the City of Johannesburg approved the amendment of the Johannesburg Town – Planning Scheme, 1979, by the rezoning of a Part of Erf 827, Parktown, from "Special" to Special for shops, restaurants, take-away facilities, coffee shops, offices, places of instruction and public garages" subject to amended access conditions.
