



NOTICE 2489 OF 2002

NOTICE IN TERMS OF REGULATION 21 (10) OF THE DEVELOPMENT FACILITATION REGULATIONS IN TERMS OF THE DEVELOPMENT FACILITATION ACT, 1995

Rudolf van Vuuren Consulting Urban and Regional Planners has lodged an application in terms of the Development Facilitation Act for the establishment of a land development area on a portion of Portion 539 of the Farm Doornkloof No. 391 JR, Gauteng.

The development will consist of the following:

A high security residential and office park development, consisting of 4 security access erven, 215 medium sized (average of approximately 650 square metres) residential erven, 1 erf set aside for a clubhouse and 11 office erven of approximately one hectare each. Residential erven will gain access to interlinked parkland creating a rural character.

2. if your comments constitute an objection to any aspect of the land development application, you must appear in person or through a representative before the Tribunal on the date mentioned below.
