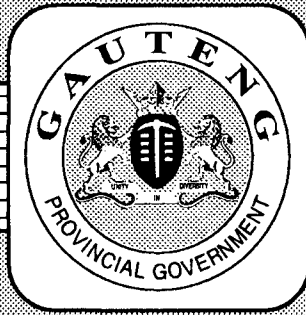

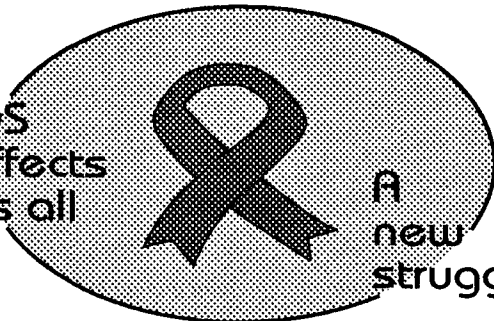

#### AMENDMENT SCHEME 0911E
