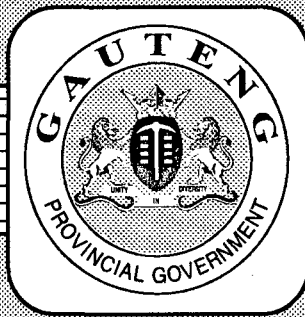

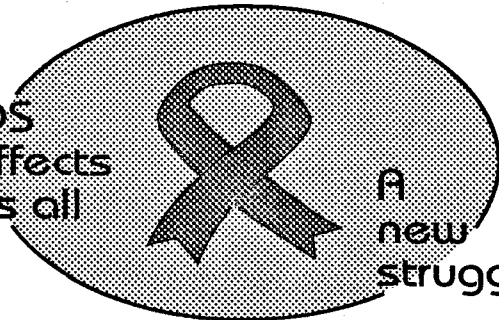

Notice No. 6770 of 2000, published in the *Gauteng Provincial Gazette Extraordinary* No. 141 dated 1 October 2000, and Notice No. 330 of 2000, published in the *North West Provincial Gazette Extraordinary* No. 5580 dated 1 October 2000, as amended, are hereby further amended by amending the Schedule thereto as follows:

AMENDMENT OF PART 6

1. *Amendment of clause 27*
