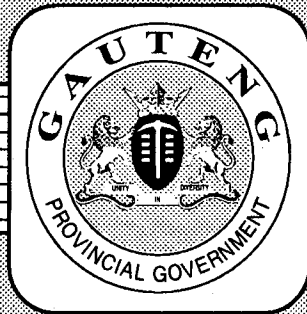

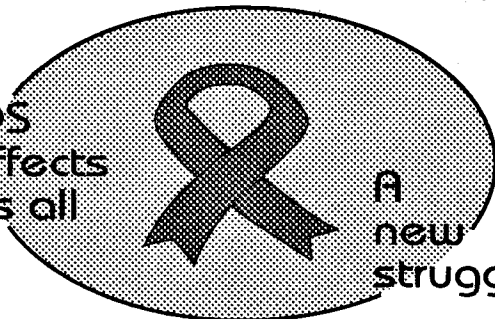

LOCAL AUTHORITY NOTICE 1875

CITY OF TSHWANE METROPOLITAN MUNICIPALITY PRETORIA AMENDMENT SCHEME 8798

It is hereby notified in terms of the provisions of section 57 (1) (a) of the Town-planning and Townships Ordinance, 1986 (Ordinance No. 15 of 1986), that the City of Tshwane Metropolitan Municipality has approved the amendment of the Pretoria Town-planning Scheme, 1974, being the rezoning of Portion 1 of Erf 1391 and Erven 1392 and 1393 Waterkloof Ridge Extension 2 to Special. The erven shall only be used for the purpose of a restaurant with a drive-through facility and a related ancillary play area for children, excluding a theater, cinema, concert hall, billiard saloon, sports arena, skating rink, dance hall or for the purpose of exhibitions of trade or industry subject to certain conditions.

Map 3 and the scheme clauses of this amendment scheme are filled with the Municipal Manager and the Director-General: Gauteng Provincial Administration. Community Development Branch, and are open to inspection during normal office hours.

This amendment is known as Pretoria Amendment Scheme 8798 and shall come into operation on the date of publication of this notice.

PLAASLIKE BESTUURSKENNISGEWING 1875

STAD TSHWANE METROPOLITAANSE MUNISIPALITEIT PRETORIA-WYSIGINGSKEME 8798

Hierby word ingevolge die bepalings van artikel 57 (1) (a) van die Ordonnansie op Dorpsbeplanning en Dorpe, 1986 (Ordonnansie No. 15 van 1986), bekendgemaak dat die Stad Tshwane Metropolitaanse Munisipaliteit die wysiging van die Pretoria-dorpsbeplanningskema, 1974 goedgekeur het, synde die hersonering van Gedeelte 1 van Erf 1391 en Erwe 1392 end 1393 Waterkloof Rif Uitbreiding 2 na Spesiaal. Die erf moet slegs gebruik word vir die doeleindes van 'n restaurant met deurry fasiliteite en 'n aanverwante speelplek vir kinders, uitgesluit 'n teater, bioskoop, konsertsaal, biljard salon, sportarena, skaatsbaan, dansaal of vir die doel van handles/of nywerheidstoonstellings, onderworpe aan sekere voorwaardes.

Kaart 3 en die skemaklousules van hierdie wysigingskema word deur die Munisipale Bestuurder van Pretoria en die Direkteur-generaal: Gauteng Provinsiale Administrasie Tak Gemeenskapsontwikkeling, in bewaring gehou en lê gedurende gewone kantoor ure ter insae.

Hierdie wysiging staan bekend as Pretoria-wysigingskeme 8798 en tree op die datum van publikasie van hierdie kennis-gewing in werking.
