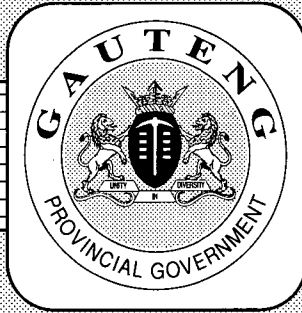

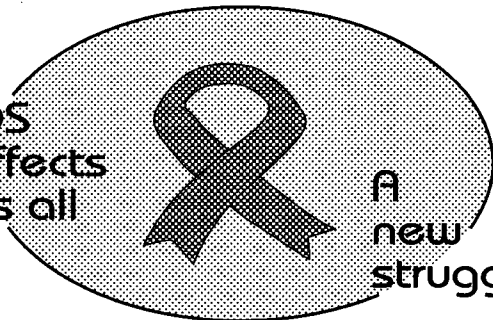

LOCAL AUTHORITY NOTICE 1885

CITY OF JOHANNESBURG METROPOLITAN MUNICIPALITY
(FORMER WESTERN METROPOLITAN LOCAL COUNCIL)

CORRECTION NOTICE

Local Authority Notice 1800 of 2002, which appeared in the Provincial Gazette Extraordinary of 7 November 2002 is hereby bettered by the following changes in the English notice:

1. In the first paragraph of the annexure the name of the Applicant must be changed from THE HWA HSIASG PROPERTY INVESTMENT CC to SOLIDBILD PROPERTIES (PROPRIETARY) LIMITED.
2. At paragraph 1.5, point A (b) the below-mentioned portion should be removed as it is a duplication of point A (c).

"By Notariele Akte No. 26/1937 S, is dit ooreengekom dat die reg tot gebruik van water toekomend aan die eiendomme vermeld onder Notariele Aktes 573/1924 S en 85/1929 S, slegs vir die genot sal dien van die eienaars van Gedeelte "H" en die Resterende Gedeelte groot 153,5042 Hektaar van die plaas "PANORAMA" No. 22, gehou onder Verdelings-sertifikaat 127/1937 en 131/1937."

3. Paragraph 1.5, point D should be deleted and should read as follows:

"By Notarial Deed No. K1201/86S dated 12 March 1986 the within-mentioned property is subject to a perpetual right of way measuring 2943 square metres in favour of the Town Council of Roodepoort indicated by figure A B C D E on diagram S.G. No. A4832/85 annexed to the said Notarial Deed No. K1201/86S and being 20 square metres in extent."

1. In die eerste paragraaf van die bylae moet die naam van die Aansoekdoener van HWA HSIASG PROPERTY INVESTMENT CC na SOLIDBILD PROPERTIES (PROPRIETARY) LIMITED verander word.
2. By paragraaf 1.5, punt A (b) moet die onderstaande gedeelte verwyder word aangesien dit 'n duplikasie van punt A (c) is

No. A4832/85 annexed to the said Notarial Deed No. K1201/86S and being 20 square metres in extent."
4. By Paragraaf 2.1.4 moet "ERF 678" bygevoeg word aangesien die voorwaarde net op die genoemde erf van toepassing is. (Sien Engelse Kennisgewing)
