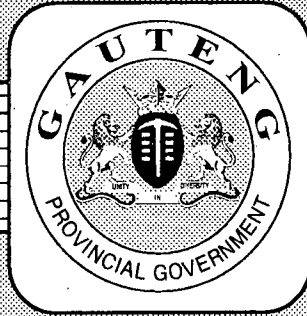

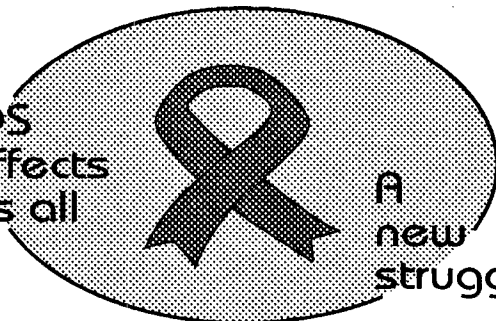



**NOTICE 3582 OF 2002****DEPARTEMENT OF PUBLIC TRANSPORT, ROADS AND WORKS****GAUTENG INTERIM MINIBUS TAXI-TYPE SERVICES ACT, 1997 (ACT NO. 11 OF 1997)****APPLICATION OF SPECIAL MEASURES IN THE AREA OF JURISDICTION OF THE EKURHULENI METROPOLITAN MUNICIPALITY.**

**I, Khabisi Mosunkutu, Member of the Executive Council for Public Transport, Roads and Works in the Province of Gauteng**, having already declared the area of Jurisdiction of the **Ekurhuleni Metropolitan Municipality** as an area where it is, in my opinion, necessary to normalise the situation in the area caused by violence, unrest and instability in the taxi industry and in the interest of passengers, and having also made known by General Notice my intention to close routes and ranks as described in the Schedule to the General Notice in terms of Section 49 (7) of the Act and, as the situation is still abnormal and as the closure of ranks and routes as mentioned hereinafter is in my opinion absolutely necessary to normalise the situation, I now make the regulations in terms of Section 49 (7) of the Act, contained in the Schedule hereto.

## SCHEDULE

The following routes and ranks are closed for minibus taxi-type services for a period commencing at **00h01 on Tuesday, 03 December 2002 until further notice;**

### 1.1 Routes

**1.1.1 GE0386 Daveyton to Kempton Park** described as follows; Turton Street, Lurrie Road, Geldenhuis Road, Pretoria Road, Zesfontein Road, M32 Kempton Park Road, Birch Road, Elm Road, Third Street, Pomona Road, Albertross Road, Kempton Park Station Taxi Rank and Back.

**1.1.2 GE0511 Daveyton to Kempton Park** described as follows; Daveyton Central Taxi Rank, Lurrie Road, Geldenhuis Road, Pretoria Road, Zesfontein Road, Birch Road, Elm Road, Pomona Road, Albertross Road, Dancihoven Road, Central Avenue, Pretoria Road, Kempton Park Taxi Rank and Back.

### 1.2 Ranks

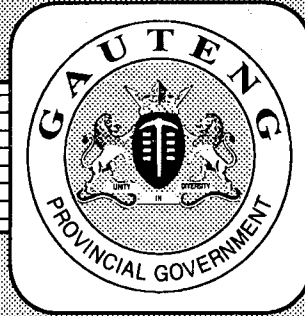
**1.2.1 Daveyton Central Taxi Rank** -- situated in Daveyton along Turton Street and Lurrie Road

2. No person may undertake minibus taxi-type services on the routes and ranks as specified in regulation 1 during the indicated period. Any person who does so will commit an offence and will be liable for conviction to imprisonment for a period not exceeding **six months** or a fine not exceeding **R10 000**, or **both a fine and imprisonment**.
3. Regulations 1 and 2 may be withdrawn by a notice in the Government Gazette in a case of reports and information received indicating that the security situation of participants in the taxi industry as well as passengers in the above area has been normalized. In this regard reports in respect of the progress to reach the agreement between the various participants in the taxi industry, supported by satisfactory supporting mechanisms to ensure that discipline in the industry can practically be enforced, will be taken into account when the normality/abnormality of the situation and the question whether regulations 1 and 2 are still necessary is assessed by the MEC for Public Transport, Roads and Works (Gauteng Provincial Government) on daily basis.
4. The Gauteng Provincial Permit Board is hereby authorised to issue temporary permits on application of the Chief Director Transportation Management (Gauteng Department of Public Transport, Roads and Works) to operators of motor vehicles with a carrying capacity of more than 16 persons, including the driver, to operate on the closed routes for the period as specified in regulation 1 or a part thereof. These permits will automatically terminate when regulations 1 and 2 are withdrawn.

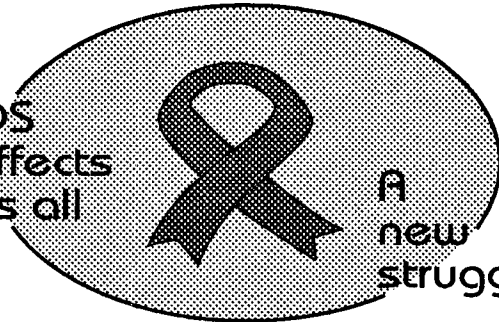

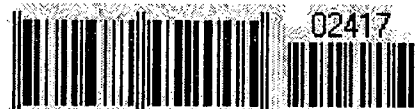

### NOTICE 3583 OF 2002

#### CITY OF TSHWANE METROPOLITAN MUNICIPALITY

#### NOTICE IN TERMS OF SECTION 6 (8) OF THE GAUTENG REMOVAL OF RESTRICTIONS ACT, 1996 (ACT No. 3 OF 1996)

It is hereby notified in terms of the provisions of section 6 (8) of the Gauteng Removal of Restrictions Act, 1996 (Act No. 3 of 1996), that the City of Tshwane Metropolitan Municipality has approved the removal of certain conditions contained in Title Deeds T38709/2002 and T65694/2002, with reference to the following properties:

Erven 621 and 622, Waterkloof Ridge.

*The following condition and/or phrases are hereby cancelled:*

*Condition:* Part of Conditions ii and 2 to 14 (inclusive) in Deeds of Transfer T38709/2002 and T65694/2002. This removal will come into effect on the 30th of January 2003 and/as well as that the City of Tshwane Metropolitan Municipality has approved the amendment of the Pretoria Town-planning Scheme, 1974, being the rezoning of Erven 621 and 622, Waterkloof Ridge, to Group Housing with a density of 14 dwelling-units per hectare, subject to certain conditions.

Map 3 and the scheme clauses of this amendment scheme are filed with the Municipal Manager and the Director-General: Gauteng Provincial Administration, Community Development Branch, and are open to inspection during normal office hours. This amendment is known as Pretoria Amendment Scheme 9382 and shall come into operation on the 30th of January 2003.

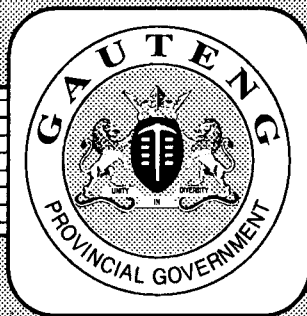

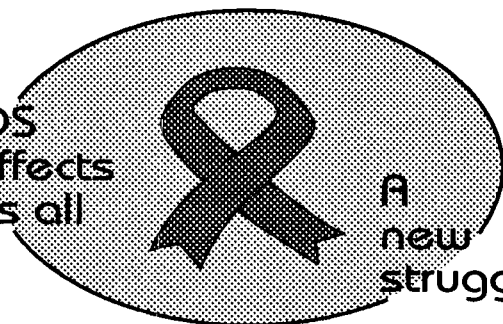

**NOTICE OF INTENTION TO MAKE REGULATIONS TO CLOSE TAXI ROUTES AND RANKS IN TERMS OF SECTION 49 (7) OF THE ACT.**
