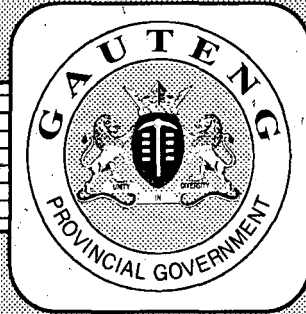

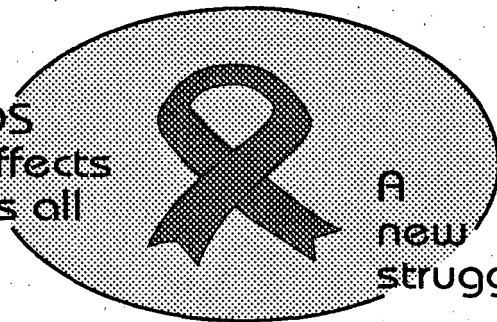

**GENERAL NOTICE****NOTICE 717 OF 2002**

ROAD TRAFFIC ACT, 1989 (ACT No. 29 OF 1989) AND ROAD TRAFFIC ACT, 1996 (ACT No. 93 of 1996)

NOTICE OF REGISTRATION OF TESTING STATION (SECTION 39 OF THE ROAD TRAFFIC ACT, 1996) AND AUTHORITY TO APPOINT EXAMINERS OF VEHICLES [SECTION 3 (1) (e) OF THE ROAD TRAFFIC ACT, 1989]

I, Mokakatlale Paul Mmakola, Director (Administration) authorized under section 91 read with section 93 of the Road Traffic Act, 1996 (Act No. 93 of 1996)—

(1) hereby give notice in terms of section 39 of the Road Traffic Act, 1996, of the registration of Great North Roadworthy Centre Testing Station with infrastructure number 49512612 as an A-Grade testing station; and

(2) hereby determine under section 3 (1) (e) of the Road Traffic Act, 1989, Great North Roadworthy Centre Testing Station with infrastructure number 49512612 to be an authority which may appoint a person as an examiner of vehicles, on condition that—

(a) such a person has obtained a diploma in the examination for examiners of vehicles at a centre approved by the Minister of Transport; and

(b) appointment takes place subject to the condition that vehicles may only be examined at Great North Roadworthy Centre Testing Station.
