



GAUTENG PROVINCIAL GOVERNMENT DEPARTMENT OF FINANCE AND ECONOMIC AFFAIRS

INVITATION BY THE MEC: FINANCE AND ECONOMIC AFFAIRS FOR NOMINATIONS TO FILL VACANCIES ON THE GAUTENG GAMBLING BOARD

- 1. In terms of Section 9(2) and 5 (1) of the Gauteng Gambling Act No. 4 of 1995, as amended ("the Act"), interested parties are hereby invited to nominate fit and proper professional persons for consideration by the responsible Member to fill vacancies on the Gauteng Gambling Board.
- 2. Professional persons who possess, inter alia the following attributes shall be considered for appointment to the Board:
 - (a) practicing attorneys or advocates with experience as such of not less than five years,
 - (b) knowledge and active involvement in the tourism industry,
 - (c) knowledge and experience in the field of welfare or of community or socio-economic development,
 - (d) knowledge and experience in the filed of labour relations,
 - (e) accountants and auditors registered in terms of section 15 of the Public Accountants' and Auditors' Act, 1991 (Act No 80 of 1991), with experience in public practice as defined in section 1 of the Act of not less than five years,
 - (f) knowledge and experience in either of the following fields:
 - business acumen
 - □ knowledge of gaming or horse racing industry
 - □ technology relevant to gambling or
 - u who are otherwise suitable to be appointed members of the Board
- 3. A person shall be disqualified from being appointed a member of the Board if such person –
- (a) is not a citizen of the Republic of South Africa, resident in the Province;
- (b) at the relevant time is, or during the preceding twelve months was, a public servant;
- (c) at the relevant time, is or during the preceding twelve months was, a member of Parliament, any provincial legislature or local authority, or any council, commission or house of traditional leaders established in terms of the Constitution;

- (d) at the relevant time is, or during the preceding twelve months was, an office bearer or employee of any party, movement, organization or body of a party political nature;
- (e) has a controlling interest or any financial or other interest in any gambling activity;
- (f) or his or her partner or associate, holds an office in or with, or is employed by, any person, company, organization or other body, whether corporate or unincorporated, which has an interest contemplated in paragraph (e);
- (g) is an unrehabilitated insolvent;
- (h) is of unsound mind, or is subject to an order of a competent court declaring such person to be mentally ill or disordered;
- (i) has at any time been convicted, whether in the Republic or elsewhere, of theft, fraud, forgery or uttering a forged document, perjury, and offence under the Act or the Corruption Act, 1992 (Act No 94 of 1992), or any offence involving dishonesty, and has been sentenced therefore to imprisonment without the option of a fine or a fine exceeding R100;
- (j) has at any time been removed from office of trust on account of misconduct; or
- (k) is a member of the family of a person contemplated in section 6 (b), (c), (d), (e) or (f) of the Act.

Appointment will be made on a non-executive part-time basis. The member shall hold office for a period of five years and shall be eligible for re-appointment.

Interested persons are hereby invited to nominate candidates for appointment to the Board by not later than 30 April 2003 by submitting a comprehensive Curriculum Vitae, an acceptance of nominations by the candidate and a sworn/confirmation statement by the candidate declaring that such candidate has no financial interest whether directly or indirectly in the gambling industry
