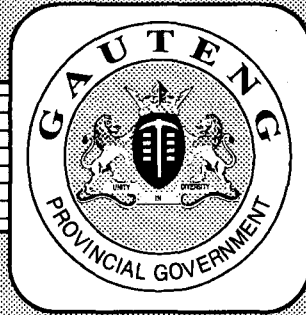

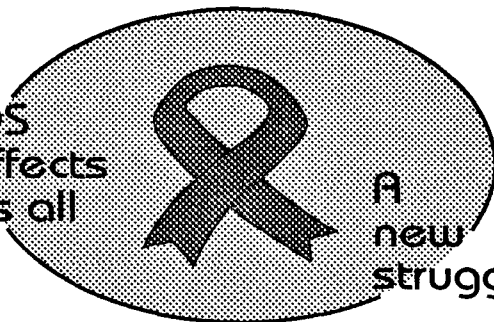

### LOCAL AUTHORITY NOTICE 617

CITY OF JOHANNESBURG  
 REMOVAL OF RESTRICTION ACT, 1996 (Act No 3 of 1996)  
 NOTICE NR. 170/2003

It is hereby notified in terms of section 6 (8) of the Removal of Restriction Act, 1996, that the City of Johannesburg has approved that;

- 1) conditions (r), (e) and (q)(i) and (ii) from Deed of Transfer T7875/1965, to be removed; and
- 2) Sandton Town-Planning Scheme, 1980, be amended by the rezoning of Erf 710, Bryanston, from " Residential 1" to " Residential 1, 8 dwelling units on site", subject to certain conditions, which amendment scheme will be known as Sandton Amendment Scheme 13-0821 as indicated on the approved application which are open for inspection at the office of the Executive Director: Development Planning, Transportation and Environment, 158 Loveday street, Braamfontein, 8<sup>th</sup> floor, A Block, Civic Centre
