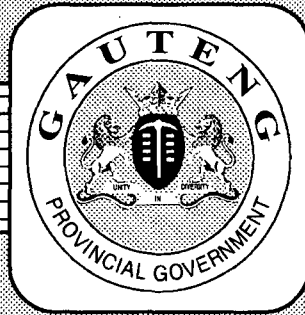

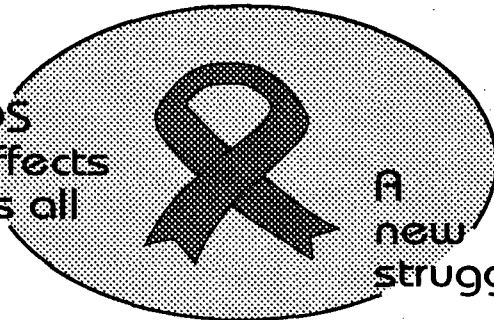

**NOTICE OF RECTIFICATION**

**PRETORIA AMENDMENT SCHEME 8916**

It is hereby notified in terms of the provisions of section 80 of the Town-planning and Townships Ordinance, 1986 (Ordinance No 15 of 1986), that Local Authority Notice 65 and 66, pertaining to approval of the amendment scheme with regard to the land in the township of Annlin Extension 87, dated 16 January 2003, is hereby rectified as follows in the English text:
