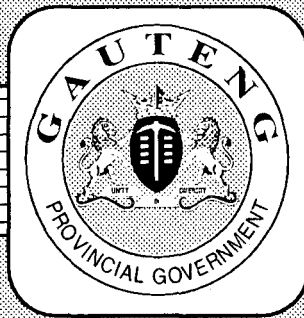

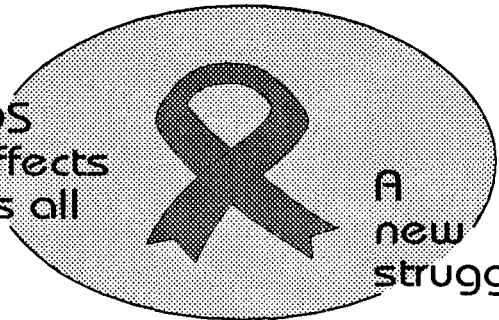

The notice concerning the declaration as an approved township in respect of the Township Spartan Extension 26 published under Local Authority Notice 873 dated 19 May 2003 is hereby corrected as follows:

In the "Conditions of Establishment" substitute the entire condition 1.3 (Disposal of Existing Conditions of Title comprising sub-paragraphs 1.3.1, 1.3.2 and 1.3.3) with the following:

**1.3 DISPOSAL OF EXISTING CONDITIONS OF TITLE**

All erven will be made subject to existing conditions, servitudes and reservation of mineral rights, but excluding

- 1.3.1 Notarial Deed 8/1929S as amended by Notarial Deed 2997/1978S which affects Erf 883 only
- 1.3.2 Notarial Deed 1115/1939S which does not affect the township
- 1.3.3 Notarial Deed 125/1963S which affects Erf 819 only
- 1.3.4 Notarial Deed 1385/1974S which affects Erven 801, 819, 834, 842 and 883 only
- 1.3.5 Notarial Deed 3617/1985S which does not affect the township
- 1.3.6 Notarial Deed 2782/2002S which will not be passed on to erven in the township
- 1.3.7 Notarial Deed 2783/2002S which will not be passed on to erven in the township
- 1.3.8 Notarial Deed 2784/2002S which does not affect the township.
